**Rae Bareli:** Leader of the Opposition in the Lok Sabha, Rahul Gandhi, is on a two-day visit to his parliamentary constituency of Rae Bareli, where he participated in a MNREGA meeting organized by the party and strongly criticized the central BJP government. He accused the government of weakening the original spirit of MNREGA. ### Sabarimala Theft Case: ED Raids 21 Locations in 3 States, Intensifies Money Laundering Probe

**Thiruvananthapuram:** The Enforcement Directorate (ED) on Tuesday expanded its investigation into the gold theft case linked to the Sabarimala temple, launching a major operation simultaneously across Kerala, Tamil Nadu, and Karnataka. A total of 21 locations in the three states were raided as part of the probe into alleged money laundering. This action comes at a time when a Special Investigation Team (SIT) constituted under the supervision of the Kerala High Court is already conducting a criminal investigation into the case. The SIT has so far arrested 13 people in this high-profile case, who are currently in judicial custody. The primary objective of the ED's latest raids is to uncover clues related to the transaction of proceeds of crime and the concealment of assets.

To gather information while in Pakistan, Doval roamed the streets of Lahore disguised as a Muslim.

## From 'America First' to 'America Alone': A Year of Trump's Presidency

US President Donald Trump has completed one year in office. This year has been quite turbulent for the United States and the entire world. After coming to power on January 20, 2017, Trump rapidly and strictly implemented his "America First" policy. While this brought some immediate benefits to his supporters, it weakened America's global influence and accelerated the emergence of a multipolar world order, with several powerful nations rising to prominence. Domestically, the Trump administration issued more

than 225 executive orders in its first year. Immigration remained his top priority. Nearly 600,000 people were deported from the US in one year. National Guard troops were deployed in several cities in the name of border security. While supporters called these measures tough and necessary,

the government faced strong criticism for family separations, wrongful arrests, and allegations of human rights violations. Large protests erupted in Los Angeles, Minneapolis, and other cities. On the economic front, tax cuts, high tariffs, and reduced government spending boosted industries in some sectors, but also led to increased inflation. This directly impacted the middle class and the poor. Layoffs in government departments and constant policy changes weakened the administrative system. In foreign policy, Trump adopted a unilateral approach.

## Jharkhand and Tata Steel Sign Historic Agreement for 11,000 Crore Investment

Under the leadership of Chief Minister Hemant Soren, the Jharkhand government and Tata Steel Limited signed a significant Letter of Intent (LoI) at the World Economic Forum (Davos). This agreement outlines an investment of over 11,000 crore in new-age green steel technologies. This will propel the state towards a sustainable, carbon-neutral industrial future and create large-scale direct and indirect employment opportunities. According to a press release issued by the Chief Minister's Secretariat on Tuesday, this partnership will implement cutting-edge technologies from the Netherlands and Germany in Jharkhand, enabling the state to play a leading role in the global shift towards green manufacturing while maintaining harmony with nature.

**Pioneering Next-Generation Ironmaking Technologies** - The Jharkhand government stated that the cornerstone of this investment is revolutionary ironmaking technologies such as HIsarna and EzyMelt, with a proposed investment of 7,000 crore. The unique feature of the HIsarna technology is that it allows the use of indigenous coal and low-grade iron ore, reducing dependence on expensive imports and making steel production more cost-effective. Combined with carbon capture and storage, this technology has the potential to reduce carbon dioxide emissions by up to 80 percent. Following a successful pilot project in the Netherlands, Tata Steel plans to establish a commercial plant with a capacity of approximately 1 million tonnes per year in Jamshedpur by 2030. Meanwhile, the EzyMelt (Electrically Assisted Syngas Melter) technology will further strengthen the sustainability of the traditional blast furnace process. This is the world's first solution of its kind, which uses syngas to reduce coke consumption and can reduce carbon emissions by approximately 50 percent.

**A New Dimension for Industrial Infrastructure** - In addition to ironmaking innovations, this investment package also includes a state-of-the-art combi mill worth 1,500 crore and a tinplate expansion worth 2,600 crore.

## Deputy Commissioner-cum-District Magistrate of Jamtara, Mr. Ravi Anand, IAS, held a public grievance redressal session in his office chamber to listen to people's problems

**Jamtara:** Deputy Commissioner-cum-District Magistrate of Jamtara, Mr. Ravi Anand, IAS, organized a public grievance redressal session in his office chamber to listen to the problems of the general public. More than 35 people presented their problems to the Deputy Commissioner during the public grievance redressal session. In the public grievance redressal session, more than 35 complainants presented their grievances to the Deputy Commissioner. These included land-related issues, problems with neighbors preventing construction, housing problems, non-receipt of pension amounts, land encroachment cases, complaints of excessive electricity bills, failure of the Circle Officer to evict encroachers from government land despite orders from the DC/SDO court, and matters related to the selection of Anganwadi workers and helpers. The Deputy Commissioner listened attentively to various types of problems and forwarded the

applications to the concerned offices for further action as per rules. The Deputy Commissioner directed that several cases be expedited and the Deputy Commissioner's office be informed of the outcome. An elderly woman who came with her grandson for pension received an on-the-spot solution. During the public grievance redressal session, an elderly woman came with her grandson. The woman told the Deputy Commissioner that she was 62 years old but was not receiving her pension. The Deputy Commissioner immediately instructed the concerned official to enroll her in the pension scheme. During the investigation, it was found that the elderly woman's pension had been approved since December 12, 2024, and the amount was being credited to her bank account every month, although the woman had not checked her bank account for a long time. When the Deputy Commissioner informed the elderly woman that Rs. 12,000 had been deposited into her bank account, the elderly woman and her grandson expressed their happiness

and thanked the Deputy Commissioner. To protect against the cold, the Deputy Commissioner gave a blanket to an elderly man at the public grievance redressal camp; he also received an assurance that action would be taken on his complaint. Meanwhile, an



elderly man from Narayanpur narrated his plight to the Deputy Commissioner, stating that his name had been removed from the housing scheme list, that he was being harassed, and that he had not received a blanket from the block office despite the severe cold. The Deputy Commissioner took his problem very seriously and instructed the concerned officials. He also immediately provided the elderly man with a blanket, which made the man very happy, and he left for his home. After hearing the complaints at the public grievance redressal camp, the Deputy Commissioner directed that a report on the matter related to Anganwadi workers and helpers be submitted within 24 hours. At the

public grievance redressal camp, three applications were received related to the selection of Anganwadi workers and helpers, and these applicants had previously appealed to the Deputy Commissioner at similar camps. The Deputy Commissioner expressed strong displeasure at the lack of action on their applications over such a long period. He instructed the District Social Welfare Officer to take the matter seriously and obtain an investigation report from the concerned CDPO/Circle Office within 24 hours and submit the file. He stated that if the report was not received within the stipulated time, departmental action would be initiated against those responsible. "District residents should feel free to present their problems to us at the public grievance redressal meeting," says Deputy Commissioner. The Deputy Commissioner appealed to the district residents, stating that a public grievance redressal meeting is being held every Tuesday. He urged them to come on Tuesdays and present their problems without hesitation, assuring them that the district administration would resolve the issues according to the rules.

## Violence during public hearing of private coal company, assault inside the tent, lakhs worth of damage

**Barkagaon (Jharkhand):** A group of villagers attacked another group during a public hearing organized by the Jharkhand State Pollution Control Board for a private coal company at the local football ground on Tuesday. The attack caused chaos and the atmosphere turned violent due to the people protesting against the public hearing. According to eyewitnesses, a large number of miscreants, armed with traditional and sharp weapons like spears, arrows, and sickles, arrived at the public hearing site in tractors and directly entered the tent. Most of them were wearing masks, mufflers, and helmets to cover their faces. In a pre-planned manner, they brutally assaulted the farmers and villagers present there. Even women were not spared and were beaten, leading to screams and cries at the scene. Their clear objective was to disrupt

the public hearing process. During the violence, there was widespread vandalism in the tent, hundreds of chairs were damaged, and the arrangements for the event were completely destroyed. Meanwhile, Leader of the Opposition Mr. Babulal Marandi condemned the incident on the X platform and questioned the government's functioning. Local former MLA Ms. Amba Prasad also reached the spot and spoke to the villagers.

## District Level Scholarship Sanction and Monitoring Committee Meeting Concluded

A meeting of the District Level Scholarship Sanction and Monitoring Committee was held in the office chamber at the Collectorate, under the chairmanship of District Magistrate-cum-Deputy Commissioner Ms. Anjali Yadav, IAS, with the objective of ensuring effective implementation, timely sanction, and transparent distribution of various scholarship schemes operating in the district. During the meeting, the Deputy Commissioner conducted a detailed review of the current status of scholarship schemes for students belonging to pre-matric, post-matric, minority, Scheduled Caste,



Scheduled Tribe, Backward Class, and other eligible categories. She instructed the concerned departments to approve the applications of all eligible students on time and transfer the scholarship amount to their bank accounts promptly, so that no student's education is hampered due to financial reasons. The Deputy Commissioner laid special emphasis on ensuring transparency and accuracy

in the scholarship application verification process. She said that incomplete or erroneous applications should be promptly brought to the notice of the students through the concerned schools/colleges for correction. She also directed that pending applications be processed quickly and all procedures be completed within the stipulated time frame. During the meeting, an amount of Rs. 4.18 crore was

sanctioned for 22,379 children belonging to SC, ST, and OBC categories from classes one to eight, which will be sent to their bank accounts through PFMS. It was also directed in the meeting that awareness campaigns should be conducted at the school, college, and panchayat levels for the widespread dissemination of information about scholarship schemes, so that more and more eligible students can benefit from the schemes. In addition, emphasis was placed on regular monitoring of data entry, verification, and payment status on the online portal. District Welfare Officer Mr. Sudhir Prasad Singh, along with other staff members of the District Welfare Department, were present in the meeting.

## Godda Sub-Division Level Training-cum-Workshop on Safe and Empowered Women – Empowered Jharkhand, Child Marriage-Free Jharkhand was organized

**Godda:** A Godda Sub-Division Level Training-cum-Workshop was organized at the local Nagar Bhawan, Godda, to effectively implement the state government's ambitious resolutions of "Safe and Empowered Women – Empowered Jharkhand" and "Child Marriage-Free Jharkhand." awareness programs in their respective areas, establish communication at the school, panchayat, and community levels, and ensure timely delivery of benefits to those truly in need. He stated that negligence at any level will not be tolerated in these matters. During the program, detailed information was provided on the provisions, benefits, grievance redressal process, and various state government schemes under the Social Evils Prevention Scheme. The awareness, monitoring, reporting mechanisms, and prompt action processes under the "Child Marriage Free Jharkhand" campaign

were also highlighted. The program also explained how to ensure legal action by promptly intervening through the relevant departments upon receiving information about child marriage. Nasreen provided detailed information on women empowerment, child protection, and the

eradication of social evils. Speakers at the program emphasized that child marriage is not only a crime, but also poses a serious obstacle to the physical, mental, and educational development of girls. Active participation from every section of society

is essential to prevent it. During the training session, detailed information was provided on various state and central government schemes, including the Child Marriage Prohibition Act, legal provisions related to women's safety, the Chief Minister's Kanyadaan Scheme, the Savitribai Phule Kishori Samridhi Yojana, sponsorship schemes, the Women's Helpline (181) and the Child Helpline (1098). Special emphasis was placed on prompt action in case of suspected child marriage, strengthening the information system, and interdepartmental coordination. During the



workshop, instructions were given to conduct awareness campaigns in schools, Anganwadi centers, Panchayat representatives, and the community to educate people about the ill effects and legal consequences of child marriage. The need to prioritize education, health, and skill development to empower women and girls was emphasized. During the program, people were made aware of road safety through street plays. Also, everyone collectively resolved that they would play an active role in their respective fields and continuously strive for the creation of a child marriage-free, safe and

strong Jharkhand. During the program, the peer leader of the adolescent group operating under the Child Marriage Free Jharkhand Abhiyan program enthralled the officials and the audience by staging a street play to prevent child marriage. The play showed how child marriage causes adolescent girls to miss their studies and their dreams remain unfulfilled. Officials from various departments, supervisors, Anganwadi workers/assistants, representatives of voluntary organizations and employees from other related departments were present in the program.

They held detailed discussions on pressing issues related to women and MNREGA in the state. She said that during the conversation with Lamba, an agreement was reached to intensify the struggle against the exploitation of women, which will infuse new energy among women activists. During the discussion, the crucial role of women in the MNREGA struggle being waged by the Congress at the national level was highlighted. The minister said that the number of women workers among those receiving employment under MNREGA is significant, but the central government is conspiring to deprive women of the employment they receive in their villages and homes by making changes to MNREGA. An agreement was reached to launch an organized movement against such efforts.

**Congress demands action over alleged insult to Shankaracharya on Mauni Amavasya**

**Ranchi:** The alleged incident of insult to Shankaracharya Maharaj on Mauni Amavasya has sparked outrage among Sanatanis across the country. Condemning the incident, former president of the East Singhbhum District Congress Committee, Anand Bihar Dubey, termed it a well-planned conspiracy against Sanatan culture and the Hindu saint tradition. He said that this incident is not only an insult to a saint but also an act that hurts the sentiments of the entire Hindu society. Anand Bihar Dubey said that the festival of Mauni Amavasya symbolizes restraint, silence, penance, and spiritual peace. The kind of misbehavior meted out to a Jagadguru like Shankaracharya, who had come for a dip in the Triveni on such a sacred occasion, reflects the height of anti-social and irreligious mentality. Calling it completely unacceptable, he said that such incidents are part of a conspiracy to spread anarchy in society and break religious harmony. He stated unequivocally that the Indian National Congress would not ignore this incident at any cost. If the administration fails to take swift and stringent action against the culprits, Congress workers will be forced to take to the streets and protest democratically. Those who are protecting the culprits should also not be spared. On Tuesday, Anand Bihar Dubey sent a memorandum to the President and the Union Home Minister through the Deputy Commissioner. The memorandum demands the formation of a high-level inquiry committee for an impartial investigation into the incident, an inquiry into the alleged indecent and insensitive behavior of some police officials, the strictest possible legal action against the guilty individuals, and ensuring complete security for Shankaracharya.

**Violence erupts during private coal company's public hearing; mob storms venue, causing extensive damage worth lakhs**

Former Chief Minister Babul Marandi questions law and order situation

**(Jharkhand):** A group of villagers attacked another group during a public hearing organized by the Jharkhand State Pollution Control Board for a private coal company at the local football ground on Tuesday. The attack triggered chaos and violence. The atmosphere turned violent due to the presence of people protesting against the public hearing. According to eyewitnesses, a large number of rioters, armed with traditional and sharp weapons like spears, arrows, and sickles, arrived at the public hearing venue in tractors and stormed directly into the tent. Most of them were wearing masks, mufflers, and helmets to conceal their identities.



In a pre-planned manner, they brutally attacked the farmers and villagers present there. Even women were not spared and were also beaten, leading to screams and panic at the scene. Their clear objective was to disrupt the public hearing process. During the violence, the tent was extensively vandalized, hundreds of chairs were damaged, and the arrangements for the event were completely destroyed.

Meanwhile, Leader of the Opposition Babul Marandi condemned the incident on the X platform and questioned the government's functioning. Local former MLA Amba Prasad also reached the spot and spoke to the villagers.

**Secretary Ajay Singh holds meeting to ensure success of MDA campaign, issues instructions**

The Jharkhand government has started preparations for the MDA-2026 campaign in mission mode to eradicate filariasis. In this regard, a crucial meeting of the State Task Force was held on Tuesday at Nepal House, chaired by Additional Chief Secretary of the Health Department, Ajay Singh. In the meeting, Additional Chief Secretary Ajay Kumar Singh gave important instructions regarding the successful implementation of the Mass Drug Administration (MDA) program, which is scheduled to begin on February 10. He also discussed in detail the campaign strategy, potential



challenges, and the roles of various departments. In addition, he discussed the prevention of vector-borne diseases such as malaria, dengue, chikungunya, kala-azar, and Japanese encephalitis. The meeting was informed that filariasis is a serious parasitic disease spread by mosquitoes. Ajay Singh said that so far, 57,436 lymphedema patients have been registered in Jharkhand. The state government has given top priority to the eradication of filariasis and has decided to implement it in mission mode. He informed that under MDA-2026, the target is to administer anti-filarial drugs to approximately 1.75 crore people in 14,496 villages across 87 blocks

of 14 districts of the state, starting from February 10. For this, a system of real-time monitoring has been established through mission squads, volunteers, and control rooms at the panchayat level. The Additional Chief Secretary instructed that along with drug distribution, drug consumption must be ensured. It should be transformed into a mass movement. The meeting was attended by Campaign Director Shashi Prakash Jha, Deputy Director Dr. Lal Majhi, representatives from various departments, and representatives from the World Health Organization (WHO) and Piramal Swasthya.

# Alcohol, sugary drinks stay cheap in India as WHO flags weak taxes in South-East Asia

**New Delhi, Agency:** Despite strong evidence linking alcohol and sugar-sweetened beverages to cancers, liver disease, obesity, diabetes, heart disease and road injuries, both products are becoming more affordable in India, the World Health Organisation (WHO) has warned, calling weak tax design across South-East Asia a major public-health failure. Across two recent global reports, the WHO ranks South-East Asia — including India — among the weakest regions on health-oriented taxation. While taxes exist, they have failed to curb consumption because they are not linked to alcohol strength or sugar content, nor adjusted for inflation or rising incomes. As a result, prices fall in real terms even as health harms rise.

On alcohol, the Global Report on Alcohol and Health and Treatment of Substance Use Disorders notes that only about one-quarter of countries worldwide automatically adjust excise taxes for inflation. South-East Asia performs especially poorly on alcohol-content-based taxation, which WHO considers the most effective deterrent. Instead, flat or category-based taxes allow high-strength alcohol and binge drinking to remain affordable. Doctors say the consequences are already visible. Dr Sharad Malhotra, Senior



Consultant & Director, Gastroenterology and Hepatology, Aakash Healthcare, said hospitals are seeing younger patients with advanced liver disease, alcohol-related cancers, heart problems and mental health disorders linked to heavy drinking. Rising incomes, celebrity promotion and peer pressure, he warned, are fuelling binge drinking among youth. "When alcohol keeps getting cheaper, we are effectively subsidising future disease and premature deaths," he said.

WHO identifies alcohol as a leading risk factor for premature death and disability, contributing to liver cirrhosis, cancers, cardiovascular disease, injuries and violence. The burden is shifting rapidly to low- and middle-income countries like India, where consumption is rising faster than policy responses.

A similar pattern is seen with sugary

drinks. The WHO Global Report on the Use of Sugar-Sweetened Beverage Taxes 2025 found that the median total tax on a 330-ml sugary carbonated drink in South-East Asia is about 22.7%, but most of this comes from GST or VAT — broad consumption taxes that do little to reduce intake. The excise component remains weak.

Excise taxes on sugary drinks exist in six of eight South-East Asia countries, including India, but levels are too low to significantly reduce consumption. Rising incomes have again outpaced price increases, making sugary drinks progressively cheaper.

Dr Anoop Misra of Fortis C-DOC said sugary drinks are driving obesity, type-2 diabetes and heart disease, increasingly in adolescents and young adults, warning that many packaged fruit juices contain as much sugar as soft drinks. WHO says weak tax design blunts impact, as fruit juices, sweetened milk drinks and ready-to-drink teas and coffees are often lightly taxed, allowing consumers to switch products rather than cut intake. Only 25% of countries tax sugary drinks based on sugar content. Consumer policy expert Prof Bejon Kumar Misra of Healthy You Foundation said India's GST-heavy approach weakens the health signal."

## As Poland courts Pakistan, India advises zero tolerance for terror

**New Delhi, Agency:** Amid Poland's efforts to step up ties with Pakistan, external affairs minister S Jaishankar told his visiting Polish counterpart Radoslaw Sikorski that Poland should display zero-tolerance for terrorism instead of fuelling the terrorist infrastructure in India's neighbourhood. Warsaw has been looking to expand its trade, defence and energy ties with Pakistan and Sikorski visited Islamabad in Oct last year to further scale up bilateral cooperation. Jaishankar told him he was no stranger to this part of the world and was also familiar with the longstanding challenge of cross-border terrorism. "Poland should display zero-tolerance for terrorism and not help fuel the terrorist infrastructure in our neighbourhood," he said. The meeting also saw India's discord with Europe on the Russia-Ukraine war spill out in the open as Jaishankar stressed that selective targeting of India on the Ukraine issue is unfair and unjustified.

# 'Contempt of court': SC irked by Maneka Gandhi's criticism of its order in stray dog case

**New Delhi, Agency:** The Supreme Court on Tuesday expressed displeasure over former Union minister Maneka Gandhi's remarks criticising apex court orders in the stray dog issue, stating that she has committed contempt of court.

A Bench of Justices Vikram Nath, Sandeep Mehta and N V Anjaria said the former minister has made "all kinds of comments" against everyone without even thinking.

Questioning senior advocate Raju Ramachandran who appeared for Gandhi, the bench said, "You said the

court should be circumspect in its remark but have you asked your client what kind of remarks she has made? Have you heard her podcast? She has made all kinds of remarks against everybody without even thinking. Have you seen her body language?"

The Bench said it was not initiating contempt proceedings against the former Union minister because of the court's magnanimity.

Justice Mehta asked Ramachandran what budgetary allocation has Maneka Gandhi, as a former Union minister, helped in getting to eradi-

cate the stray dog problem. Ramachandran replied that he has appeared even on behalf of terrorist Ajmal Kasab and budgetary allocation is a policy matter.

"Ajmal Kasab did not commit contempt of court but your client has," Justice Nath remarked.

The hearing in the case is still underway.

## Boost for defence exports as Rajnath flags off 1st batch of Pinaka guided rockets for Armenia

**New Delhi, Agency:** In a big boost for India's arms exports, defence minister Rajnath Singh on Sunday flagged off from a facility in Nagpur the first batch of guided Pinaka rocket system bound for Armenia.

The export of the multi-barrel rocket launcher, renowned for its accuracy and extended range, signalled India's emergence as a reliable supplier of cutting-edge defence technology. The Pinaka launchers, which are highly capable weapon systems with variants that can strike targets at up to 75 km -- the latest trial version can even touch a range of 120km -- have been increasingly promoted by India as part of its growing arms exports. Rajnath said the export of Pinaka missiles developed at Solar Defence & Aerospace facility have begun, demonstrating the capabilities of the defence industry. "India is no longer just an importer but is rapidly moving towards becoming an

exporter," he said. The minister said that due to increasing participation of the private sector, India's defence exports, which were at less than Rs 1,000 crore 10 years ago, have now reached a record Rs 24,000 crore. Domestic defence production, which stood at just Rs 46,425 crore in 2014, has grown to a record Rs 1.51 lakh crore now, he added.

The Indian Army has already inducted Pinaka Mk-I Enhanced variant (EPRS) after successfully completing trials in April 2022.

# Hope against Chikungunya: ICMR steps in as cases rise across India

**New Delhi, Agency:** With Chikungunya continuing to leave thousands of Indians with prolonged and debilitating joint pain, the Indian Council of Medical Research (ICMR) has moved to fast-track a potential antiviral treatment, inviting Indian companies to help develop and manufacture an experimental RNA-based therapy.

The initiative comes amid a sustained disease burden. World Health Organisation surveillance data show India recorded over 30,000 suspected Chikungunya cases and nearly 1,800 laboratory-confirmed cases between January and March 2025, with Maharashtra, Karnataka and Tamil Nadu among the worst-affected states.

Against this backdrop, scientists at ICMR's National Institute of Virology (NIV), Pune, have developed an experimental RNA-interference-based therapy that

directly targets the Chikungunya virus. In pre-clinical studies, the treatment completely suppressed viral replication in laboratory cell lines and mouse models by silencing two essential viral genes — E2 and nsP1.

The findings have prompted ICMR to offer the technology for transfer to industry.

Explaining its significance, Dr Ekta Gupta, Professor of Clinical Virology at ILBS, New Delhi, said, "RNA interference blocks viral protein formation by targeting messenger RNA. In Chikungunya, NIV's RNAi approach targeting E2 and nsP1 has shown complete viral suppression in vivo with a single dose.

While laboratory results are encouraging, clinical trials are needed. This is important because there is currently no vaccine or antiviral for a disease that causes significant morbidity in parts of the country."

# High drama in Tamil Nadu assembly: Governor R N Ravi walks out; alleges 'national anthem insulted'

**New Delhi, Agency:** Tamil Nadu governor R N Ravi walked out of the state assembly on Tuesday before delivering his inaugural address, expressing disappointment over what he said was a lack of respect for the national anthem.

He also claimed that his microphone was switched off during the proceedings. "I am disappointed. National Anthem was not given due respect," the governor said. He added that "it is unfortunate that his speech was interrupted."

Inside the House, the situation led to a sharp exchange, with assembly Speaker M Appavu urging the governor to follow established rules and customs of the assembly.

Later, Raj Bhavan issued a press release explaining the reasons behind the governor's walkout. "The governor's mic was repeatedly switched off, and he was not allowed to speak," the



statement said. It also claimed that issues such as "atrocities against Dalits and sexual violence against Dalit women are sharply increasing," but were "totally bypassed in the speech."

The release further alleged that the "National Anthem is yet again insulted, and the Fundamental Constitutional Duty is disregarded."

Meanwhile, AIADMK general secretary and leader of opposition in

assembly Edappadi Palaniswamy raised slogans with party leaders at the entrance of assembly after they walked out from the House over law and order issues in Tamil Nadu.

This was not the first such incident. A similar episode took place last year when governor Ravi walked out of the Assembly in what he described as "deep anguish," alleging that the "constitution of Bharat" and the National Anthem were insulted.

With Assembly elections drawing closer, the session is being viewed as politically crucial. Opposition parties, including the AIADMK and the BJP, are expected to level several allegations against the ruling party and the state government.

Chief minister M K Stalin and his Cabinet colleagues are preparing to counter the attacks, setting the stage for a tense and politically charged assembly session.

# Punjab government approves modernisation of bus terminals in five districts

**Chandigarh, Agency:** The Punjab government has approved the modernisation of bus terminals in Ludhiana, Jalandhar, Sangrur, Patiala and Bathinda through a structured Public Private Partnership (PPP) model to strengthen public transport infrastructure.

Transport Minister Laljit Singh Bhullar said on Saturday the decision was taken under the leadership of Chief Minister Bhagwant Singh Mann with the objective of improving passenger facilities, safety, accessibility and overall efficiency at major transport hubs.

He said the bus terminals serve as key connectivity points for both rural and urban populations and play an important role in inter-state



travel to neighbouring states of Himachal Pradesh, Jammu and Kashmir, Haryana, Delhi and Rajasthan.

According to the minister, Ludhiana and Jalandhar bus termi-

inals handle between 75,000 and one lakh passengers daily, while Patiala and Bathinda witness footfall of around 50,000 passengers every day. Bhullar said the projects will be implemented under Design-Build-

Finance-Operate-Transfer or Build-Operate-Transfer models to ensure quality services while maintaining fiscal prudence.

The modernisation will focus on improving waiting areas, sanitation facilities, lighting, signage, organised boarding systems and parking arrangements, along with better crowd management during peak hours. He said provisions for barrier-free access will be included to ensure ease of movement for senior citizens and persons with disabilities.

## List WB voters with 'logical discrepancy': SC to poll panel

**New Delhi, Agency:** As almost 1.4 crore West Bengal voters face "logical discrepancy" notices requiring submission of documentary proof for the special intensive revision (SIR), Supreme Court ordered the Election Commission on Monday to display the list of such people in panchayat and block offices and gave them 10 more days to furnish documents to establish their credentials for inclusion in the state electoral rolls. Given the size of work and incidence of violence against EC officials conducting the drive in West Bengal, a bench of CJI Surya Kant and Justices Dipankar Datta and Joymalya Bagchi asked the state to provide manpower as required by EC and directed the DGP to ensure maintenance of law and order for smooth conduct of the exercise.

## Address structural flaws in higher education

Despite having one of the world's largest higher education networks, including over 1,300 universities, the academic and research standards in India are woefully short of international standards. They fare poorly in the global rankings, puncturing the oft-repeated narrative of being a 'Vishwaguru'. A recent nationwide survey has revealed several structural flaws in the higher education sector, particularly concerning the faculty. Nearly one in three faculty members reported receiving no formal training on how to teach before entering the classroom, and among those who did, almost 70% found that training ineffective, the Jetri Faculty Worklife Report 2025 has pointed out. There are over 1.6 million faculty members teaching over 40 million students spread across higher education institutions in the country. One of the key findings of the study, based on responses from 547 faculty members across public and private institutions, was that nearly a quarter of faculty end up spending most of their time on administrative tasks that are primarily critical to institutions rather than students. This imbalance suggests that institutional priorities may crowd out time for student-focused interactions. In contrast, globally ranked institutions prioritise faculty-student interactions and project-based learning more than anything else. Faculty members who spend more time on student-centred work tend to remain longer at their institutions, suggesting that meaningful teaching may help retain the faculty. When faculty feel unable to do the work they value most, disengagement follows. Similarly, lecture-based teaching remains the dominant mode in India, even as nearly two-thirds of faculty report persistent struggles with student engagement.

Many faculty members juggle teaching, research and administrative duties without enough support to manage competing demands, leaving them overwhelmed, feeling caught between priorities and struggling to maintain balance. As they are increasingly pulled away from student-focused tasks, the critical bonds that drive both student and faculty engagement risk fraying — affecting the heart of the academic experience. The surveyed faculty members admitted to feeling ill-equipped to address students' mental-health issues, diverse learning needs, and the responsible use of artificial intelligence (AI) tools. Another big challenge pertains to student motivation. Nearly two-thirds of the respondents cited lack of student engagement as a huge challenge. It was observed that student commitments did not come from a place of genuine passion, as they seemed to care more about collecting activities they could put on their resume or on social media. Teaching methods also play a major role in driving student engagement. The survey has shown that lecture-based abstract teaching remains the overwhelming default for faculty.

## JEE Main January 2026: The First Big Test of the Year for Engineering Aspirants

As the calendar turns to January 2026, lakhs of young aspirants across the country will step into examination centres with a single dream — a strong start in the Joint Entrance Examination (JEE) Main. Conducted by the National Testing Agency (NTA), the January session of JEE Main is not just an entrance test; it is the opening chapter of a long academic journey towards the IITs, NITs, IIITs and other centrally funded technical institutions. For many students, this session is an opportunity to assess their preparation under real examination conditions, while for others it is the decisive attempt to secure a high percentile early in the year.

**Exam Schedule:** January 2026 Session: The JEE Main January 2026 session is scheduled to be held in the second half of January, spread over multiple

days to accommodate the large number of candidates. As in previous years, the examination will be conducted in two shifts each day — a morning shift and an afternoon shift — in Computer Based Test (CBT) mode. Paper 1 (for B.E./B.Tech) will be held on most days, while Paper 2A (B.Arch) and Paper 2B (B.Planning) will be conducted on selected dates. Each candidate will be allotted a specific date, shift and centre, details of which will be mentioned on the admit card issued by NTA a few days before the examination. The multi-day format ensures smooth conduct, but it also means that candidates should not compare difficulty levels across shifts. Normalisation of scores, a well-established process, takes care of any variation. What matters most is individual performance on the allotted day.

**What to Carry on the Exam Day:** One of the most common causes of anxiety on exam day is confusion about permitted and prohibited items. Clarity on this front helps candidates stay composed. First and foremost, the JEE Main Admit Card is mandatory. Candidates must carry a printed copy, preferably

in colour, as it contains essential details such as roll number, exam centre address, reporting time and important instructions. Along with the admit card, a valid photo identity proof is required. Acceptable IDs include Aadhaar card, school ID, passport, PAN card or voter ID. Candidates must also carry a passport-size photograph, preferably the same as uploaded in the application form. Some centres may require it for attendance verification. In terms of stationery, a transparent ballpoint pen is usually allowed. Rough work sheets will be provided at the examination centre and must be returned after the exam. Equally important is knowing what not to carry. Mobile phones, smart watches, calculators, digital watches, earphones, wallets, bags and any kind of electronic gadget are strictly prohibited. Even metallic accessories and jewellery are discouraged. Candidates are advised to wear simple clothing without large buttons or metallic elements to avoid delays during security checks.

**Reporting Time and Centre Discipline:** Reaching the examination centre well before the reporting time mentioned on the admit

card is crucial. Entry gates typically close 30 minutes before the exam begins, and latecomers are not allowed under any circumstances. Once inside, candidates must follow instructions given by invigilators and security staff. Biometric verification and frisking are standard procedures. Though time-consuming, these are essential for maintaining the integrity of the examination. Silence, discipline and patience are the unwritten rules inside the centre. Any form of unfair means or misconduct can lead to immediate disqualification, and in serious cases, debarment from future examinations.

**Exam Day Preparation: The Mental Game:** By January, preparation is largely complete. The exam day is not about learning new concepts, but about managing the mind. The night before the exam should be reserved for light revision and adequate rest. Revising short notes, formulas and key concepts is more effective than attempting full-length mock papers at the last moment. A good night's sleep does more for performance than any extra hour of study. On the morning of the exam, candidates should

have a light, familiar meal. Experimenting with food is best avoided. Hydration is important, but excess intake should be avoided to prevent discomfort during the test.

**Strategy Inside the Examination Hall:** Once the exam begins, the first few minutes should be spent calmly reading instructions on the screen. Rushing into questions without understanding the paper structure often leads to avoidable mistakes. Experts consistently advise starting with the subject one feels most confident about. This builds momentum and reduces anxiety. The JEE Main paper is designed to test not just knowledge, but also time management and decision-making. Candidates should be mindful of negative marking. Attempting every question is neither necessary nor wise. Intelligent selection — answering questions that are clearly understood and leaving ambiguous ones — often results in a better score. Time allocation across Physics, Chemistry and Mathematics should be roughly balanced, but flexibility is key. If one section proves unexpectedly difficult, it is better to move on rather than get stuck.

**A Calm Start to a Long Journey:** The JEE Main January 2026 session marks the first national academic milestone of the year. It is demanding, competitive and intense — but it is also fair, structured and predictable for those who approach it with clarity. In the end, success in JEE Main is not defined by panic or last-minute heroics, but by steady preparation, a calm mind and disciplined execution on the exam day. As thousands of students take their seats across centres in January, the real test will not just be on the computer screen, but in their ability to remain composed under pressure — a lesson that extends far beyond the examination hall.

## Surge of returning refugees deepens shelter crisis in Afghanistan



With a rising number of Afghan refugees returning home, access to shelter has emerged as a major challenge, as many returnees struggle to secure housing and basic necessities, Tolo News reported. Officials of the Islamic Emirate said measures are being taken to address the issue, with land distribution continuing in several provinces. Hamdullah Fitrat, deputy spokesperson of the Islamic Emirate, said more than 3,000 plots of land have been provided so far to forcibly deported returnees. So far, 3,046 plots of land have been distributed in various provinces among returnees who were forcibly expelled. The distribution process is ongoing. Also, under the directive of the esteemed

Amir al-Mu'min, emergency aid for returnees has accelerated, including food, non-food items, and cash assistance, Fitrat said. In a related development, the Ministry of Urban Development and Housing said the Joint Permanent Committee for the Resettlement of Migrants has distributed land to over 2,800 families in Kunar, Laghman, Maidan Wardak, Kandahar, Kunduz, Paktia, and Bamyan, Tolo News reported. The ministry also said that land distribution for another 5,000 families has begun in Nangarhar, according to Tolo News.

Kamal Afghan, the ministry's spokesperson, said the land distribution programme is being expanded province by province. The Ministry of Urban Development and

Housing has launched land distribution step-by-step in all provinces, and the program will, God willing, expand to ensure the fair distribution of plots to all returnees, Afghan said. Meanwhile, returnees arriving from Pakistan said they continue to face serious difficulties due to a lack of shelter and essential facilities, and urged faster allotment of land and the provision of basic services, Tolo News reported.

"Now I'm going to Baghlan, but I have nothing there. We sold everything we had just to pay rent. We ask the Islamic Emirate to help us with land and food distribution," said Yar Mohammad, a returnee. Another returnee, Sher Mohammad, called for urgent support amid harsh weather conditions. "Our request to the government is to give us blankets and cash aid because it's cold here and we're struggling," he said. According to statistics cited in the report, nearly seven million Afghans have returned from various countries since the return of the Islamic Emirate to power, underlining the need for sustained planning to resettle and support returnees.

## Taxes won't push Delhi towards green transport

Delhi's latest electric vehicle proposal makes one thing clear: when policymakers run out of ideas to make cleaner technology attractive, they reach for taxes. The Delhi government is considering extending its green cess to petrol and CNG vehicles, on top of higher diesel levies, explicitly to make conventional cars more expensive and electric vehicles seem relatively cheaper. That is not climate leadership.

It is fiscal coercion dressed up as environmental policy.



The premise is simple: make conventional vehicles more expensive and consumers will switch. But that assumes EV adoption is being delayed by attitude, not access. For many buyers, petrol and CNG vehicles remain the rational choice because they are cheaper upfront, easier to refuel, and more reliable for daily use, advantages that taxes do nothing to erase.

Delhi already offers some of India's most generous EV incentives: zero road tax, waived registration fees, and purchase subsidies of Rs 5,000 per kilowatt-hour.

Yet electric vehicles still account for only about 12-14 per cent of new registrations. If subsidies alone have not delivered mass adoption, a 1-2 per cent cess on conventional vehicles is unlikely to do so either. For middle-income households buying two-wheelers or small cars, this tax is not a behavioural nudge, it is a price

shock. For commercial drivers, delivery fleets, and small businesses, this shift functions less as an incentive and more as a penalty.

EVs remain an impractical option for many operators: charging infrastructure is limited to few urban corridors, electricity supply is unreliable in large parts of the country, and resale markets for electric vehicles are still immature. Raising the cost of petrol vehicles does nothing to address these structural gaps; it simply increases operating costs for those who have no viable alternative. Global experience points in a different

direction. In countries where EV adoption has accelerated, such as Sweden, Norway, and Finland, the transition followed a sequence: build strong charging networks, ensure availability of vehicles across price segments, foster competition among manufacturers, and only then phase in penalties on high emission vehicles.

Therefore, Suryakumar's aim will be to score as many runs as possible in this series to regain his form for the T20 World Cup. Suryakumar took over the captaincy of the T20 team in 2024, and since then, the Indian



team has won most of its matches. In the last two years, the Indian T20 team has only faced defeat in a few matches. Therefore, they will be strong contenders for victory in this match against the Kiwi team. However, the Indian team will miss the batting of Tilak Varma. Tilak will not be playing in this match due to surgery. Shreyas Iyer has been included in his place.

On the other hand, the New Zealand team is also quite strong. Their morale is high after winning the previous ODI series, which will benefit them, although their path will not be easy. The Indian team has won 18 out of their last 25 matches. The team has aggressive batsmen like Abhishek Sharma and a spinner like Varun Chakravarthy. Meanwhile, New Zealand has won

only 13 out of the 21 T20 International matches played since the 2024 T20 World Cup. They have aggressive opening batsman Devon Conway. The team has a spinner like captain Mitchell Santner and a fast bowler like Jacob Duffy. The presence of in-form Daryl Mitchell and Glenn Phillips has strengthened the team considerably. Fast bowler and all-rounder Christian Clarke will be in the team for this match because Michael Bracewell and Adam Milne are both unfit. The Indian team has all-rounder Hardik Pandya. Spinner Varun will be a key weapon for the Indian team. Varun's four overs between the seventh and 15th overs often change the course of the match. The two teams

India A's first match in the tournament will be against the UAE on February 13. This will be followed by the

## Manchester City signs Crystal Palace defender Marc Guehi

The 25-year-old England defender, Marc Guehi, came close to joining Liverpool on the September 2025 transfer deadline day, but the deal fell through at the last minute. Now, Guehi will be seen in a Man City jersey. Guehi captained Crystal Palace in the FA Cup final in May, leading them to a title victory against Manchester City. He has played 26 international matches for England so far. Manchester City manager Pep Guardiola had recently expressed



concern about the lack of players in defense. This had become a major challenge for City, who are currently in second place in the Premier League, seven points behind Arsenal. Before Guehi's signing, Guardiola had said, "Without John (Stones), without Ruben (Dias), and without Josko (Gvardiol), we are in a difficult situation, and this is not just a matter of one match but a long-term problem.

## Australian Open: Venus Williams and Ekaterina Alexandrova knocked out in women's doubles first round

American legend Venus Williams and Russia's Ekaterina Alexandrova have been eliminated in the first round of the women's doubles at the Australian Open 2026. The American-Russian pair was defeated by France's Elsa Jacquemot and Colombia's Emiliana Arango 6-3 (3), 6-4. This loss ends Venus's campaign at Melbourne Park. Earlier, the two-time Australian Open finalist

Venus was knocked out in the first round of the women's singles after losing to Olga Danilovi. This was Venus's first appearance at Melbourne Park since 2021 and her first tournament outside the US since 2023. The seven-time Grand Slam winner, who received a wildcard into the tournament, became the oldest woman to play in the main draw of the Australian Open. The previous record was held by Japan's Kimiko Date, who lost in the first round in 2015 at the age of 44. Venus has reached the Australian Open final twice, the semi-finals in 2001, and the quarter-finals six times.



Her tournament record stands at 54-21. In addition, she has won the women's doubles title four times in Melbourne—in 2001, 2003, 2009, and 2010 with her sister Serena Williams, and also won the mixed doubles title in 1998 with Justin Gimelstob. After a 16-month break, Venus returned to tennis in July 2025 and played three tournaments. She defeated compatriot Peyton Stearns 6-3, 6-4 in the first round of the Mubadala Citi DC Open but then lost to Magdalena Frich. In August, Venus lost in the first round of the Cincinnati Open to Spain's Jessica Bouzas-Mancero

## Bangladesh maintains its stance on not playing in India at the T20 World Cup

Bangladesh government's sports advisor Asif Nazrul clarified on Tuesday that Bangladesh will not change its stance on playing in India in the ICC T20 World Cup. He also dismissed reports that Scotland would replace Bangladesh if the latter withdrew from the tournament. Asif Nazrul said that Bangladesh has refused to play in India citing security concerns and has requested the ICC to hold its matches in co-host Sri Lanka. He said the government's position on the issue is clear and unwavering. Talks were held between Bangladesh Cricket Board (BCB) and ICC officials in Dhaka last weekend, but no solution could be reached. The stalemate deepened when the Board of Control for Cricket in India (BCCI) instructed the IPL franchise Kolkata Knight Riders to release Mustafizur Rahman from their team amidst the current political tensions. According to sources, the ICC has set a deadline of January 21 to resolve the matter. If Scotland were to replace Bangladesh, they would need at least 15 days to prepare, as Scotland



is the highest-ranked team that failed to qualify for the World Cup. Bangladesh had also proposed changing its group, but Ireland refused to agree to this. Asif Nazrul told reporters, "I am not aware of any plan to replace us with Scotland in the ICC T20 World Cup. If the ICC tries to impose unfair conditions on us under pressure from the Indian cricket board, we will not accept them." He further added, "There have been instances in the past where Pakistan refused to travel to India and the ICC changed the venue of the tournament. We have also demanded a change of venue on logical grounds and cannot be forced to play in India under any kind of unreasonable pressure."
