## PM hands over appointment letters to 61,000 youths at Rozgar Mela, says it's an invitation to nation-building

### Amidst bitter cold, Russia launches major attack on two Ukrainian cities



Kyiv: Russia launched major aerial attacks on Ukraine's capital Kyiv and its second-largest city Kharkiv early Saturday morning. According to officials, at least 13 people were injured in these attacks carried out with drones and missiles. Two people are in serious condition, while 11 were injured in Kharkiv. According to media reports, the mayor of Kyiv said that loud explosions were heard in several parts of Kyiv. He said that the attacks occurred in two different districts of the city, located on both banks of the Dnieper River. He added that the injured have been hospitalized and their condition remains serious. According to the Ukrainian Air Force, Russia used both drones and missiles in this attack. More than 100 drones were used in the attack on Kyiv. The head of the Kyiv military administration said that drone attacks were recorded in at least three districts, causing fires in two locations.

### Bangladesh Elections: US Tilt Towards Jamaat-e-Islami Raises India's Concerns



Dhaka: A major shift is unfolding in South Asian geopolitics just ahead of the general elections in Bangladesh scheduled for February 12, 2026. This change in US foreign policy has brought not only Bangladeshi politics but also India's security interests into the spotlight. The US is now signaling direct dialogue and engagement with Jamaat-e-Islami, Bangladesh's most prominent and controversial Islamist party. According to a recently surfaced report, a senior US diplomat stationed in Dhaka admitted in a private meeting with local journalists that Bangladesh has now tilted towards Islamic ideology. The diplomat suggested to the journalists that they give members of Jamaat's student wing, Islami Chhatra Shibir, a platform in mainstream media programs. The US believes that Jamaat has now become a political force that cannot be ignored. While the US embassy has described this as routine dialogue, the diplomats' approach clearly indicates that Washington now considers Jamaat a legitimate political stakeholder.

Kolkata: Humayun Kabir, the TMC MLA who was expelled from the party and gained national attention after laying the foundation stone for the Babri Masjid in West Bengal, has set a condition for an alliance with the BJP. Kabir says that if he is assured that he will be made the Chief Minister, he is ready for an alliance. It should be noted that after being suspended from the TMC at the end of last year, Kabir formed a new party. He named this party the Janata Unnayan Party (JUP). According to media reports, MLA Humayun Kabir has said that he is ready to form an alliance with the BJP if he is made the Chief Ministerial candidate. He has also called for an alliance with the Congress, CPI-M, and ISF.

### Even after so many years, do we still have to prove that we are citizens of this country

Kolkata: West Bengal Chief Minister Mamata Banerjee said that 3 to 4 people are committing suicide every day due to concerns over the National Register of Citizens (NRC). More than 110 people have lost their lives so far, and 40-45 people are fighting for their lives in hospitals. After so many years, do we still have to prove that we are citizens of this country? Mamata Banerjee made these remarks at an event commemorating Netaji Subhas Chandra Bose's birth anniversary. According to media reports, CM Mamata

said that the names of more than 58 lakh voters have been removed from the draft voter list released in December. She said that there are a total of 7.6 crore voters in the state, of which the citizenship of 1.66 crore voters has been questioned. They have been sent notices for hearings to re-verify their documents. CM Mamata said that different spellings of the same surname are common in Bengal. Giving her own example, she said that her surname is written as both Banerjee and Bandyopadhyay, but those conducting the NRC don't even understand this.

### Winter Storm Fern's Catastrophic Threat: The Shadow of White Death Looms Over 230 Million People in the US

The United States is currently facing a severe natural disaster that has heightened concerns among meteorologists. A warning has been issued for an extremely powerful blizzard, named Winter Storm Fern, which is threatening the lives of over 230 million people. Experts claim that this storm could break records from the past several decades. This is not just ordinary snowfall, but a deadly combination of snow, freezing rain, and Arctic cold that has the potential to bring the entire country to a standstill. The severity of this storm can be gauged from the fact that its

intensity and the speed of the icy winds will be at their peak. This storm, which is expected to last from Friday to Monday, will leave behind a blanket of snow more than a foot deep and deadly frost. In light of this impending danger, more than 1,400 flights scheduled for Saturday have already been canceled, leaving busy airports like Dallas and Fort Worth deserted. Additionally, there is a strong possibility of power lines breaking due to heavy snowfall and freezing rain, potentially plunging thousands of homes into darkness amidst the biting cold. The most dangerous aspect of this disaster is the accompanying polar vortex cold air.

### India's Electoral Model a Hit, Now Several Countries Worldwide Will Conduct Special Intensive Revision

India's electoral innovations have made a global impact in making democratic processes more transparent and accurate. The Special Intensive Revision (SIR) of voter lists will no longer be limited to India, as most democratic countries' Election Management Bodies (EMBs) have also emphasized adopting this method for purifying their voter lists. This significant consensus was reached at the conclusion of the three-day international

conference on 'Democracy and Election Management' (IICDEM-2026) held at Bharat Mandapam. Election management bodies from 42 countries and heads of missions from 27 countries participated in the conference. All representatives unanimously expressed their commitment

to making voter lists error-free in their respective countries and providing every voter with a photo identity card. On the final day of the conference, the 'Delhi Declaration 2026' was shared. India's Chief Election Commissioner (CEC) Gyanesh Kumar provided details of the declaration's five key pillars. He stated that all participating countries will now work together in five areas: accuracy of voter lists, election conduct, research and publications, advanced use of technology, and training and capacity building. The Chief Election Commissioner clarified that an accurate voter list prepared according to the law is the true foundation of any democracy. He emphasized that election management bodies should continuously strive to provide all voters with photo identity cards for transparent elections.

**Cyber gang that defrauded people of crores of rupees in the name of KYC updates busted, 4 arrested from Jharkhand and Bengal**

New Delhi: The cyber police of the South-West district have busted a large inter-state cyber fraud gang that was cheating bank customers on the pretext of KYC updates. Police have arrested four accused from Jharkhand

(Jamtara-Dhanbad region) and West Bengal in this connection. The accused posed as bank officials to trap people. Mobile phones, SIM cards, and digital evidence related to the fraud have been recovered from the accused.

Mahavir Sharma alias Neel (27), Pradyumna Tiwari, Ankit Mishra, Bhupendra Kumar Mishra, and Adesh Kumar Singh (36), He Arun Kumar Tiwari (45), said that the 77-year-old

# Joint inspection of the full dress rehearsal and parade practice for the grand Republic Day celebrations was conducted

**Goddha:** At the local Gandhi Maidan, District Magistrate-cum-Deputy Commissioner Miss Anjali Yadav, IAS, and Superintendent of Police Mr. Mukesh Kumar, IPS, jointly inspected the final full dress rehearsal and parade practice for the successful organization of the Republic Day celebrations. During the program, the Deputy Commissioner instructed the police personnel and various schools to finalize their preparations, ensure 100% adherence to social distancing during the parade, complete the final cleaning of the grounds, and finish the stage decoration and painting work. The Deputy Commissioner appealed

to the district residents to celebrate Republic Day peacefully, imbued with a spirit of patriotism, and to take a pledge for the unity, integrity, and prosperity of India. She also stated that the use of plastic flags is prohibited during Republic Day. Superintendent of Police, Godda, Mr. Mukesh Kumar, IPS, stated that all police officers and personnel should participate in the Republic Day celebrations with complete discipline and that any remaining shortcomings should be addressed as soon as possible. Police officers and personnel were instructed to participate in the Republic Day ceremony in clean uniforms. The program included contingents of IRB personnel, male and female



police personnel, Home Guard personnel, and school children, whose performance was inspected in sequence. After the inspection, the Deputy Commissioner and the Superintendent of Police held a meeting with the concerned officials to discuss in detail the parade salute, march-past, flag hoisting procedure, stage

arrangements, arrival and departure of guests, outline of cultural programs, sound system, electricity, sanitation, drinking water, first aid, fire safety, and traffic and security arrangements. They instructed the concerned departments and assigned officers to ensure a coordinated, timely, and error-free

event. From a security perspective, instructions were given regarding crowd management, the chief guest's address, entry and exit arrangements, barricading, passes and seating arrangements for media personnel, tableau screening and evaluation committee, honoring freedom fighters, marking seating areas for

media personnel near the flag hoisting site, CCTV surveillance, and deployment of adequate police force at sensitive points. The contingents participating in the parade were instructed to practice with discipline, uniformity, and according to the prescribed standards. **Nationwide Strike on February 12 to Protect Workers' Rights**

**East Singhbhum:** Vishnu De, convenor of the joint platform of central trade unions and independent federations of Kolhan division, said that a nationwide one-day general strike will be held on February 12, 2026, against the anti-labor and anti-farmer policies of the central government. He said that this strike is the beginning of a decisive struggle to protect the workers' rights achieved through sacrifices and against pro-corporate policies. Speaking at a press conference held in Jamshedpur on Saturday, Vishnu De said that the central government has implemented four labor codes without consulting the trade unions, the objective of which is to weaken the right to strike, render unions ineffective, and convert permanent jobs into contract and temporary arrangements. He alleged that through the new labor force policy-2025, an attempt is being made to eliminate the concept of collective bargaining and tripartite dialogue. The joint platform says that the rampant privatization of railways, coal, steel, defense, banks, insurance, energy, and other public sectors has posed a threat to the country's self-reliant economy. Furthermore, instead of filling the more than 65 lakh vacant government positions, outsourcing and contract labor are being promoted. Essential commodities, education, and healthcare are becoming unaffordable for the common people, while farmers have yet to receive a legal guarantee of Minimum Support Price (MSP). The major demands of the trade unions include the repeal of the four labor codes, statutory MSP for all agricultural products, regularization of contract and temporary workers, halting the privatization of public sector undertakings, revival of the Heavy Engineering Corporation (HEC), guaranteed education, healthcare, and housing for all, and the withdrawal of new laws detrimental to the interests of workers and farmers. Vishnu Dey appealed to the workers, farmers, youth, students, and people's organizations of Jharkhand to make the strike a success.

**Daylight Burglary After Breaking into House, Two Accused Arrested**

A daylight burglary was reported on Saturday morning at Khan Building, opposite Vishwanath Temple on Mango Gurudwara Road. Around 7:30 AM, masked criminals, disguised as laborers, entered the building and broke into a locked house. At the time of the incident, the homeowner, Akhileshwar Dubey, a medical representative, was away in his village preparing for his son's wedding. The criminals first broke the lock on the main door and entered the house. When they couldn't break the lock on an inner room, they broke down the door itself. They then looted jewelry and cash from the cupboards and boxes before easily making their escape. The extent of the loss will only be assessed after Akhileshwar Dubey returns. The building owner, Umakant Singh, said that since the movement of laborers is common in the morning, no one suspected anything. People thought that repair work was going



on at Dubey's house. A short while later, a neighbor noticed the broken door and informed others, which led to the discovery of the burglary. Upon receiving information about the incident, former BJP leader Vikas Singh reached the spot and informed the local police station. With the help of local youths and the police who arrived at the scene, two of the accused were apprehended. The police have taken them into custody for questioning and have launched a search for other members of the gang. Vikas Singh, who was present at the scene, said that drug use has increased rapidly in the area, leading to a continuous rise in crime.

**Youth Arrested with Brown Sugar**

Late Friday night, Mango police, in a major operation against the illegal drug trade, raided the Daigutu Forest Line area and arrested a youth with brown sugar. **Savarna Mahasangh protests at Deputy Commissioner's office against UGC's new equality regulations, submits memorandum**

On Saturday, the Savarna Mahasangh Foundation of India staged a strong protest at the district level against the regulations issued by the University Grants Commission in January 2026 to promote equality in higher education institutions. The protest was held at the Deputy Commissioner's office complex in Jamshedpur. During the protest, Savarna Mahasangh workers raised slogans such as "Equal rights are our right," "Withdraw the anti-constitutional regulations," and "Equal justice for all classes." The protest was peaceful, but the workers showed strong resentment towards the notification. Following this,



a delegation of the Savarna Mahasangh submitted a memorandum in the name of establishing equality in higher education institutions, focuses only on the rights of Scheduled Castes, Scheduled Tribes, Other Backward Classes, and disabled students, while completely ignoring the constitutional rights and protection of students from the general category. # Indian national, 3 relatives shot dead in family dispute in US; children hid in closet

**New Delhi, Agency:** A domestic shooting in the US state of Georgia on early Friday morning left four dead, including an Indian national, after an alleged family dispute escalated into violence at a residence in Lawrenceville, authorities said.

Three children who were inside the home at the time survived after hiding in a closet, one of whom managed to call emergency services.

According to the Gwinnett Daily Post, Gwinnett County police responded to a "shots fired" call around 2.30 am (local time) at a house in the 1000 block of Brook Ivy Court. Officers found four adults inside the home suffering from gunshot wounds.

All four were pronounced dead at the scene.

Investigators said three



young children - aged seven, 10 and 12 - were inside the house when the shooting began. To protect themselves, the children hid together in a closet. Police said the 12-year-old managed to call 911, providing crucial details that helped officers reach the location within minutes.

The children were not

injured and were later taken into the care of a family member. Because officers arrived quickly and found the suspect's vehicle still in the driveway, K-9 units were deployed to search the area. A police dog tracked the suspect to a nearby wooded area, where he was arrested without incident.

**Suspect and victims**

**identified:** Police identified the suspect as Vijay Kumar, 51, of Atlanta. He has been charged with four counts each of aggravated assault, felony murder and malice murder, along with one count of first-degree cruelty to children and two counts of third-degree cruelty to children.

The victims were identified as Kumar's wife, Meenu Dogra, 43, of Atlanta, and three relatives - Gourav Kumar, 33, Nidhi Chander, 37, and Harish Chander, 38 - all residents of Lawrenceville.

Investigators said an argument began between Kumar and Dogra at their home in Atlanta, after which they travelled with their 12-year-old child to the Brook Ivy Court residence, where the other three victims lived with two children.

**HYDERABAD, Agency:** About 300 dog carcasses were found dumped in a pit in Jagtial district in the latest case of alleged mass killing of strays in Telangana, taking the total number of dogs found dead in the state this month to nearly 900. The latest alleged killings in Pega pally, 200km from Hyderabad, occurred Thursday, allegedly on orders from the village sarpanch, animal rights activists claimed.

Based on a complaint by Preethi Mudavath from Stray Animal Foundation of India, police registered an FIR against the village sarpanch and gram panchayat secretary, among others, under sections 325 read with 3(5) of BNS, and Section 11(1)(a) of Prevention of Cruelty to Animals Act, 1960 (dealing with killing and poisoning by multiple persons).

Preethi told media villagers informed her the lethal injections were administered by two women.

Cases of mass killings of strays have been reported from Kamareddy, Hanumakonda and Ranga Reddy districts in the last few weeks. In most cases, FIRs were registered against newly elected sarpanches and other representatives who allegedly ordered the killings to fulfil their poll promises.



## Trucks carrying loose loads to be hard topped; govt to notify rule soon

**NEW DELHI, Agency:** In a move to address the menace of loose items, such as soil, construction materials and municipal waste, often falling from both uncovered or tarpaulin-covered trucks, the govt will soon make it mandatory for these vehicles to have "mechanised covering" - automated or machine-assisted methods for covering.

This will be part of the updated Truck Body Code. Road transport minister Nitin Gadkari has said the code will be notified soon. Officials said the changes to the code have been adopted by a committee under the road transport ministry that has representatives from the industry as well. media

has learnt that the truck-manufacturing industry has sought two years to implement the code while the govt is keen to roll it out in the next one year.

There have been several Supreme Court orders directing proper covering of trucks carrying loose and protruding loads, but there has been little compliance due to poor enforcement.

## Acid attacks: Centre approves policy for Rs 10,000 monthly aid to survivors in Chandigarh

**Chandigarh, Agency:** The Government of India has approved a policy of the Chandigarh Administration for providing monthly financial assistance to acid attack survivors.

This information has been placed before the Punjab and Haryana High Court during hearing of the case recently. In a letter to the Chief Secretary, UT of Chandigarh, under Secretary to the Government of India Ministry of Home Affairs has informed that the competent authority has approved financial assistance scheme "SAHAS-Support and Assistance for Healing Acid Survivors" of Chandigarh Administration to provide a monthly financial assistance of Rs 10,000 to be provided to each acid attack victim in the Union Territory of Chandigarh, subject



to following conditions.

Instead of new scheme, it may be made a separate component of already running schemes i.e., Union Territory of Chandigarh Victims Assistance Scheme 2012 or Pension to the Persons with Disabilities as deemed appropriate. Suitable economic criteria will also be incorporated for selection

of beneficiaries and continuation of pension as deemed appropriate.

Benefit will be transferred through DBT mode only and suitable safeguards, including with respect to residency, will be incorporated for selection of beneficiaries so that the scheme is not misused. Besides, the budget need will be met from already available resources with Chandigarh Administration. The Centre's response came during a hearing of a contempt petition filed by advocate HC Arora. Arora had alleged that in a PIL filed by him, the UT administration had undertaken to pay monthly financial assistance to acid attack victims at the rate it is paid by Punjab and Haryana, but it did not keep its promise while Punjab was paying monthly a pension of Rs 10,000 since 2016.

## Wanted in multiple cases, man arrested after police encounter in Delhi

**New Delhi, Agency:** A man wanted in multiple criminal cases was arrested after a brief exchange of fire with police in southeast Delhi, an official said on Saturday.

Police laid a trap near MB Road after receiving inputs about Satish Bhati's (22) movement. When Bhati was spotted on the intervening night of Friday and Saturday and signalled to stop, he allegedly tried to escape and opened fire at the police party, a senior police officer said. "The team overpowered him after a brief exchange of fire. He was safely apprehended and disarmed on the spot," the officer said. No police personnel were injured in the incident, he added. During the search, police recovered one country-made pistol, six mobile phones sus-

pected to be snatched or robbed, and a motorcycle believed to have been used in the commission of crimes, officials said.

Preliminary investigation revealed that Bhati is a habitual offender with prior involvement in multiple criminal cases, including snatching and robbery, in different parts of the city. A case under relevant sections of the Bharatiya Nyaya Sanhita and the Arms Act has been registered, and further investigation is in progress, police added.



## Bactrian camels to Zanskar ponies: 'Animal soldiers' to join 6k military personnel at R-Day parade

**S400 to be displayed, EU contingent to participate**



**New Delhi, Agency:** From Bactrian camels to Zanskar ponies, a rare contingent of "animal soldiers" will for the first time be seen marching down Kartavya Path joining the 6,050 military personnel during the 90-minute Republic Day parade on Monday.

They will be under the command of Captain Harshita Yadav, daughter of a retired IAF officer, and from the first batch of Indian Army's Remount & Veterinary Corps.

Speaking to media, she said, "This contingent is very uniquely curated. There are two Bactrian camels from Ladakh, four Zanskar ponies, four raptors (specially-trained

birds of prey), 10 military dogs, mostly indigenous-bred. They are all Army soldiers and have different operational roles."

Perfectly adapted to extreme cold, thin air and

altitudes above 15,000 feet, the Bactrian camels, which are recently inducted in Army operations, can carry a load of up to 250 kg and traverse long distances in the cold deserts.

She said the Indian Army has been using indigenously-bred dogs for quite some time and they are trained basically for two purposes - detection (explosives, mine detection, tracking, search and avalanche rescue) and protection

## ED searches premises of Luthra brothers in Delhi, Goa

**New Delhi, Agency:** More than a month after the arrest of Gaurav and Saurabh Luthra, owners of a Goa nightclub where a deadly fire claimed 25 lives, the Directorate of Enforcement (ED) on Friday conducted searches at their premises in Delhi and Goa.

The searches were carried out at five locations in Delhi and three in Goa, including residential and office premises. The brothers own Birch by Romeo Lane, where a blaze on December 6, 2025, killed 25 people.

The operations were undertaken to probe a money-laundering angle linked to the alleged illegal functioning of the club and the role of its promoters in the backdrop of the fire tragedy. Premises linked to



Ajay Gupta, also an owner of the club, were searched.

In Goa, the ED also searched premises of then sarpanch Roshan Redkar and panchayat secretary Raghuvir Bagkar, who are alleged to have facilitated the issuance of illegal trade licences and no objection certificates to the establishment.

### The 'Mother of All Deals'

This time, January 27th, the day after Republic Day, could prove historic. A Free Trade Agreement (FTA) could be signed between India and the European Union. European Commission President Ursula von der Leyen has clearly hinted at this, calling it the "mother of all deals." This statement is natural. India, with a population of over 1.47 billion, is the world's fourth-largest economy. The International Monetary Fund (IMF) and the World Bank estimate that India's economy will be the fastest-growing in 2026-27, with a growth rate of around 6.5 percent. Gita Gopinath, former Deputy Managing Director of the IMF, estimates that India could become the third-largest economy by 2028. A trade agreement with such a country would provide European countries with a broad and diverse market. India's FTA with the European Union, a union of 27 countries with a GDP of \$22.5 trillion, a population of approximately 460 million, and an average per capita income of approximately \$49,000, will undoubtedly send a startling message to the entire world. This agreement will be extremely important for a population of over 1.93 billion. New trade avenues will open up, demand for products will increase, production will grow, and as a result, new jobs will be created. It is noteworthy that several rounds of trade negotiations between the two countries continued for 19 years. It was then named the Broad-Based Trade and Investment Agreement (BTIA), but despite several rounds of negotiations between 2007 and 2013, a trade agreement could not be reached. The European Union disagreed on issues such as market access, taxes, intellectual rights and property, labor laws and regulations, and environmental standards.

Europe's concerns about its carbon footprint persist even today. However, India has made sincere efforts to reduce carbon emissions to near-zero through alternative measures, such as forest expansion and clean energy. Clearly, the EU has understood India's seriousness regarding the environment and pollution. However, this agreement was delayed and stalled for years. Finally, in 2022, with renewed political will, negotiations began to conclude a comprehensive FTA. In the 2024-25 fiscal year, India's exports to the EU amounted to \$75.85 billion, while imports amounted to \$60.68 billion. Nevertheless, India's exports to Europe are significantly lower than those to China. The EU could now become India's largest trading partner. Currently, textiles, readymade garments, leather goods, marine products, etc.

In a vast and diverse country like India, voting rights are not merely a constitutional right but a symbol of social justice, equality, and popular sovereignty. World history bears witness to the fact that voting rights have never been readily granted by those in power. The concept of democracy developed in ancient Athens, but even there, voting rights were limited to free male citizens.

Women, slaves, and foreign nationals were denied this right. Medieval Europe was dominated by monarchies, where public political participation was unimaginable. The struggle for suffrage began with the development of modern democracy. In Britain, the working class and women gained the right to vote after a long struggle. In the United States, despite constitutionally enshrined voting rights, Black citizens were practically barred from voting until the 1960s. This history underscores the fact that suffrage is not a gift, but an achievement of mass struggles. The history of suffrage in India has also been steeped in struggle and deprivation. During colonial rule, the right to vote was extremely limited. Under the Acts of 1909, 1919, and 1935, suffrage was linked to property, taxes, and education. This right was virtually unattainable for women, Dalits, tribals, and the poor. While political consciousness grew during the freedom movement, the decisive role of the general public was still limited. In such a situation, the decision by the framers of the Constitution of independent India to grant universal adult suffrage was a historic and revolutionary step. The Indian Constitution, which came into effect on January 26, 1950, granted the right to vote to every citizen who had attained the age of 21, without any discrimination. This was later reduced to 18 years under the Constitution's 61st Amendment Act, 1988. This decision, establishing universal adult franchise in 1950, was more progressive than many developed democratic countries of the time. India's first general election, held in 1951-52, was called the largest

By the 21st century, the situation had improved somewhat. Voter turnout in the 2014 general elections reached 66.4 percent and 67.4 percent in 2019, the highest ever. In the 2024 elections, the voter turnout was 66.10 percent. It is a harsh truth that today, the very right to vote, for which the world and India have struggled for centuries, is becoming a victim of neglect and indifference. Elections come, governments are

This thinking contradicts the fundamental principles of democracy. In a democracy, it's not the abundance of options that is important, but the selection of the best option. Not voting isn't a sign of disillusionment with the system, but rather a weakening of it. When a citizen doesn't vote, they exclude themselves from the decision-making process. They surrender their right to choose their representatives and indirectly accept bad leadership. In a democracy, it's easy to complain about corruption, bad governance, and incompetent leadership, but it's also essential to introspect whether we've played our part. If a citizen stays home on voting day and later questions government policies, their moral standing is weakened. This statement may seem harsh, but it holds a profound truth: a person who doesn't vote loses their moral right to speak out against corrupt leaders in a democracy. However,

National Voters' Day was made in light of the declining youth turnout. Despite this, it's ironic that while social media is abuzz with political debate, government criticism, and ideological conflict, this same segment lags behind in reaching the polling booth. Democracy isn't strengthened solely by online discourse, but by access to the ballot box. There are special expectations from the youth. India is a young country, with a large population about to vote for the first time. If this segment remains indifferent, the future of democracy will be weakened. Young people must understand that voting isn't just a means to elect the current government, but a tool to shape the future. A single vote isn't a single vote; it combines with millions of opinions to create the power for change. This understanding needs to be internalized, only then will democracy truly flourish.

## Traffic jams are a brake on the country's progress

The country is grappling with a lack of basic infrastructure. The situation is dire everywhere. The country's political parties are not serious about providing these facilities. This is why the country suffers billions of rupees in losses every year due to the lack of these facilities. Political parties and governments blame each other for the lack of such facilities and shirk their responsibility. According to the TomTom Traffic Index 2025, Bengaluru is the second most congested city in the world. Only Mexico City has slower traffic speeds than Bengaluru. Pune, Maharashtra, is in fifth place. The report claims that people lose 168 hours a year due to Bengaluru's traffic congestion, equivalent to 7 days and 40 minutes. According to a survey by the Boston Consulting Group (BAG), the peak hours are 7 to 9 in the morning and 6 to 8 in the evening, during which commuting takes one and a half times longer than the average. Kolkata was the worst in this survey, with Bengaluru coming in sec-

ond. Despite having the highest number of vehicles, Delhi's situation remained better due to better roads. According to reports, the number of people using private vehicles in Delhi was the highest at 45 percent, while in Bengaluru this figure was 38 percent. Mumbai won the race in terms of use of public vehicles, followed by Kolkata. Bengaluru stood at the bottom in this matter where traffic jams have become common. India's four major cities - Delhi, Mumbai, Bengaluru and Kolkata - suffer a loss of Rs 1.47 lakh crore every year due to traffic jams. A recent study revealed that Bengaluru suffers a huge economic loss of approximately Rs 20000 crore every year due to traffic jams.

Thousands of people visit this city, billed as India's Silicon Valley, every year. Over the past 15 years, the city's population has grown rapidly. It now boasts nearly 15 million residents and over 10 million vehicles on its roads. The rapid growth of this population can be gauged from the fact that former Chief Minister

Basavaraj Bommai stated in a statement that by 2027, the number of vehicles in the city will exceed its population. Economic losses related to traffic congestion in Delhi are projected to reach US\$14.7 billion by 2030. Fuel wastage due to traffic congestion alone could lead to millions of dollars in losses every day, exacerbating the city's already severe air quality problems. The report found that employees spent significant time stuck in traffic, leading to significant productivity losses. The study estimates that the IT sector alone has lost approximately 7,000 crore due to traffic congestion. Furthermore, traffic congestion adversely impacts small and medium-sized enterprises.

These businesses struggle to meet delivery schedules, resulting in delayed shipments and dissatisfied customers. This, in turn, has a sharp impact on the city's economy, leading to losses of approximately 3,500 crore. Motor vehicle use in India has seen a significant increase since 2000, with the number of new vehicles doubling every 5-6 years. Although this growth was temporarily halted by the pandemic, motor vehicle use has recovered rapidly, with an average of 58,000 new vehicles registered daily in 2023-24, of which 52,000 were private vehicles. In Delhi, an average of 6.4 lakh vehicles were registered during the same period, with an average of 1,750 new vehicles registered daily. One of the rea-

sons for increasing traffic congestion is the excessive number of cars. Traffic stagnation consumes approximately 3% of India's gross domestic product (GDP). Cities are plagued by traffic congestion, which wastes 10 percent of fuel consumption. Where vehicles are stranded, they create a pollution zone, containing measurable gases such as carbon monoxide and sulfur oxide. Traffic congestion has a direct impact on pollution, as emissions from stopped vehicles can be 3 to 7 times higher than from smoothly moving traffic. Large amounts of nitrogen dioxide, carbon monoxide, and carbon dioxide are emitted, affecting local air quality and posing a threat to the health of local resi-

dents. According to the 2011 census, India's urban population was 31.16%, which, according to the World Bank's 2022 projections, is projected to reach 35% by 2020. This pace of urbanization will accelerate in the coming years, leading to an increase in the number of vehicles in metropolitan areas. Delhi will have approximately 12-13 million registered vehicles by 2023. Environmental pollution is also a serious consequence of traffic congestion.

Thirteen of the world's 20 most polluted cities are in India. Traffic congestion leads to a significant increase in vehicle carbon emissions, which deteriorates air quality and increases health problems. Several effective strategies can be adopted to address this problem. First, strengthening public transportation systems is essential. More cities should promote metro networks, electric buses, and cycle tracks. High-occupancy vehicle lanes can be implemented in India, giving priority to vehicles with more than one passenger and encouraging carpooling.

# Markets tanks nearly 1% amid widespread sell-off; Sensex slips below 82,000

**New Delhi, Agency:** Equity benchmark indices Sensex and Nifty resumed their downward journey to end nearly 1 per cent lower on Friday, dragged by widespread sell-off and the rupee depreciating to hit a record low against the US dollar.

Besides, investors rushing to safe-haven assets from riskier assets and unabated foreign capital outflows in the absence of domestic triggers added to the gloom, traders said.

The 30-share BSE Sensex tumbled 769.67 points, or 0.94 per cent, to close at 81,537.70. During the day, the index slumped 835.55 points, or 1.01 per cent, to hit an intraday low of 81,471.82.

The 50-share NSE Nifty dived 241.25 points, or 0.95 per cent, to settle at

25,048.65. In the intraday session, it plunged 264.6 points, or 1.04 per cent, to hit a low of 25,025.30.

Among the 30 Sensex constituents, Adani Ports, Eternal, IndiGo, Axis Bank, Bajaj Finserv, Power Grid, Bharat Electronics Ltd, State Bank of India, Maruti Suzuki India, Bajaj Finance, NTPC, Trent, Larsen & Toubro and Reliance Industries were the laggards.

On the other hand, Tech Mahindra, Hindustan Unilever, Infosys, Asian Paints, Tata Consultancy Services, Titan and UltraTech Cement were among the gainers.

The BSE smallcap gauge slumped 2.19 per cent, while the midcap index fell 1.56 per cent.



Foreign institutional investors (FIIs) offloaded equities worth Rs 2,549.80 crore on Thursday, while Domestic Institutional Investors (DIIs) bought stocks worth Rs 4,222.98 crore, according to exchange data.

"Indian equity markets went on a sell-off mode

despite an optimistic global market and supportive domestic PMI data. Sentiment weighed down on uptick crude oil prices, a sharp depreciation of the rupee to record lows, FIIs selling and earnings delivery falling marginally short of expectations amid premium India valuations," said Vinod

Nair, Head of Research, Geojit Investments Ltd.

Realty and PSU bank stocks underperformed on execution-related delays and profit booking, while Adani Group stocks came under pressure amid reports of potential summons by the US regulator, Nair added.

In Asian markets, Japan's Nikkei 225 index, Shanghai's SSE Composite index, South Korea's Kospi index and Hong Kong's Hang Seng index closed higher.

European markets were trading lower in mid-session deals. US equities ended higher on Thursday.

"Looking ahead, market sentiment is likely to remain cautious as investors position themselves for the upcoming Union Budget and the US Fed's interest rate decision,

where expectations are muted," he said.

Gold and silver prices rallied on Friday to hit fresh lifetime highs in the futures trade, tracking record gains in international markets amid a weakening US dollar and rising expectations of interest rate cuts by the Federal Reserve.

The rupee hit an all-time low of 92 on Friday and recovered marginally to settle at 91.88 (provisional) against the US dollar.

Brent crude, the global oil benchmark, rose 1.03 per cent to USD 64.72 per barrel.

On Thursday, the 30-share BSE Sensex climbed 397.74 points to close at 82,307.37, while the broader NSE Nifty rose 132.40 points to settle at 25,289.90.

## Bank unions to go on nationwide strike on January 27 to press for 5-day work week

Bank employee unions have decided to go on a nationwide strike on January 27 to press for a long-pending demand for a five-day work week.

If the strike proceeds, it will disrupt public sector banking operations for three consecutive days, with January 25 and 26 being holidays.

Most of the public sector banks have already informed their customers about the disruption in banking services if the strike materialises.

In response to the strike notice served by the UFBU, the Chief Labour Commissioner held a conciliation meeting on Wednesday and Thursday, the United Forum of Bank Unions (UFBU), an umbrella



organisation of nine unions of officers and employees, said in a statement.

"Besides representatives of IBA and various Banks, representatives of DFS, the Ministry of Finance, were present. From UFBU, all our 9 unions were present. Despite detailed discussions, finally there was no positive outcome out of the

conciliation proceedings," it said. Hence, it has been decided to go ahead with the strike on January 27, it added.

Currently, bank employees get the second and fourth Saturdays off each month, apart from Sundays.

The decision to declare all Saturdays as holidays was agreed between the Indian Banks' Association

and UFBU during the wage revision settlement in March 2024.

"It is unfortunate that the government is not responding to our genuine demand. There would be no loss of man-hours as we have agreed to work an extra 40 minutes daily from Monday to Friday," UFBU had said earlier this month.

The UFBU noted that RBI, LIC, GIC, stock exchanges and government offices already follow a five-day work week, arguing there was no justification for banks to lag behind.

UFBU is an umbrella organisation of nine major bank unions in India, representing employees and officers across public sector banks and some old generation private banks.

## SC seeks status reports from CBI, ED on PIL alleging banking fraud by Anil Dhirubhai Ambani Group

**New Delhi, Agency:** The Supreme Court on Friday issued fresh notices to industrialist Anil Ambani and Anil Dhirubhai Ambani Group (ADAG) on a PIL seeking a court-monitored probe into alleged large-scale banking and corporate fraud involving the group and its associate entities.

A bench led by CJI Surya Kant directed CBI and ED to file status reports in sealed covers in 10 days on the progress of their respective probe into the alleged fraud.

On November 18, 2025, the top court had issued notices to the Centre, CBI, ED, Anil Ambani, and ADAG on a PIL filed by former Union Power Secretary EAS Sarma. Noting that Ambani and ADAG had not responded yet, the apex court said this would be their final opportunity to respond to the petition.

Directing the Bombay High Court Registrar General to ensure proper service of notice on Ambani and



ADAG and to file a compliance report, the top court posted the matter for further hearing after 10 days.

Petitioner Sarma alleged that ADAG entities were involved in fraudulent diversion of public funds, fabrication of financial statements, and systemic collusion with institutional actors.

On behalf of the petitioner, advocate Prashant Bhushan said the alleged fraud was "probably the largest corporate fraud in India's history". He claimed that it had been

underway since 2007-08, though an FIR by CBI was registered only in 2025.

Bhushan criticised the probe agencies for failing to probe the alleged involvement of bank officials, asserting, "We want a status report from ED and CBI on what they are investigating. Clearly, they are not probing the collusion by the banks."

He requested the court to direct both agencies to file detailed reports on their investigation into the roles of banks and their officials in facilitating the alleged financial misconduct. The bench asked Solicitor General Tushar Mehta - appearing for CBI and ED - to ensure submission of status reports in a sealed cover within ten days. The bench also fixed the next hearing for the matter after that period.

The petitioner highlighted alleged financial irregularities across multiple ADAG entities, accusing them of large-scale diversion of public funds with regulatory failure.

## Team India eyes unassailable lead in third T20I

Buoyed by comfortable wins in the first two matches, India will enter the third T20I here on Sunday with the aim of securing an unassailable lead in the five-match series. While India will be aiming to seal the series in this match, Sanju Samson's performance is the most talked about, as Ishan Kishan's explosive comeback in the previous match has reignited debate over the team combination. Kishan's brilliant innings has again raised the question of who the team management will trust to open the innings alongside Abhishek Sharma. With only two weeks left for the start of the T20 World Cup, and India still have three more matches against New Zealand before that, the Indian team's structure appears largely settled. The team has displayed balanced performances in both batting and bowling departments so far, but uncertainty remains over

some positions, with Sanju Samson's place being considered the most crucial. In the last match, Ishan Kishan strengthened his claim with a quickfire 76 off just 32 balls, further increasing the pressure on Samson. Samson was given the opportunity to open alongside Abhishek Sharma after Shubman Gill was dropped due to his lack of impact in the T20 format, but the Kerala wicketkeeper-batsman has not fully capitalized on the opportunities he has received so far. Despite returning to his preferred batting order, his performance has clearly lacked consistency. His weakness against fast bowlers has once again been exposed. In the recent series against England, he was repeatedly dismissed by fast bowlers, and against New Zealand, he managed only 10 and six runs in the first two matches. Former

Indian batsman WV Raman also commented on the manner of his dismissals, saying that unless Samson adapts his shot selection and bat speed to the pace of the ball, it will be difficult to expect consistent performances from him. A welcome relief for India is that captain Suryakumar Yadav appears to be back to his old rhythm. He scored a half-century in T20 Internationals after a long time, scoring 82 runs off 37 balls in the last match. Abhishek Sharma, although dismissed on the first ball of the previous match, will be aiming for a big innings in this match. India had a poor start in the previous match, being reduced to six runs for two wickets. However, Kishan's aggressive batting completely changed the course of the match, and India achieved the target with 28 balls to spare. The team management will also be monitoring Axar Patel's finger injury and hope he gets adequate match practice before the World Cup. Fast bowler Jasprit Bumrah was rested in the last match and is likely to return in this match, as the fast bowlers

are being rotated due to the short intervals. This match will be a matter of pride for the New Zealand team.

The Mitchell Santner-led team may change its strategy after this crushing defeat and consider sending Daryl Mitchell up the order. However, its fielding, often considered strong,

has been disappointing in this series, with many easy catches dropped. If New Zealand is to make a comeback, it will need to improve immediately.
