



India-EU FTA final draft approved, defense and security partnership agreement also signed

India and the 27-nation European Union on Tuesday here finalized the draft of what is considered the world's largest free trade agreement (FTA) and announced a comprehensive strategic agenda to work jointly for global prosperity and security from the Caribbean Sea to the Indo-Pacific region. The final approval of the FTA and the signing and exchange of the political document concluding the agreement took place at the 16th India-EU Summit held at Hyderabad House here between Prime Minister Narendra Modi, European Council President Antonio Luis Santos da Costa and European Commission President Ursula von der Leyen. The two sides also exchanged documents for 13 agreements. These include the Joint India-EU Comprehensive Strategic



Agenda for 2030, a defense and security partnership, a comprehensive agreement on cooperation and its legal framework regarding the movement of human resources, and an agreement under the India-EU trilateral cooperation on digital innovation and skills hubs for women and youth, empowering women farmers in agriculture and food systems, solar-based solutions; early warning systems and four projects on solar-based sustainable energy transition in Africa, to be jointly implemented

India-EU Agreement Sends a Clear Message to the World: President of the European Council

The University Grants Commission's (UGC) new Equality Regulations for Higher Education Institutions, 2026, have sparked a political storm. Protests are underway in Delhi against the new rules. Students from upper-caste communities had announced a protest outside the University Grants Commission headquarters on Tuesday. Amidst the growing controversy, student groups, calling for unity, have appealed to their peers to gather in large numbers to register their protest against the new rules. Besides this, protests were also held in several places in Uttar Pradesh on Monday, and further demonstrations have been called for Tuesday. The gazette notification related to the rules was issued earlier this month. These rules mandate the creation

of robust systems to address caste-based discrimination in universities. However, many are opposing them. Critics say they are one-sided and vague and could be misused. This notification issued by the government is becoming the cause of protests, resignations, and political unrest. There is internal turmoil within the BJP over the matter. According to media reports, critics have presented these two resignations as proof that the opposition to the UGC

rules is not limited to student politics but has also reached the administrative and political system. The UGC has made it mandatory for all higher education institutions to establish Equal Opportunity Centers, Equity Committees, and a 24-hour grievance helpline to handle discrimination complaints, especially for SC, ST, and OBC students. The UGC says that the aim of these rules is to ensure fairness and inclusion on campus. Some people are protesting against this rule.

in accordance with the Constitution. Responding to a question about the opposition raising the issue of the new UGC guidelines,

Rijiju said that the government does not want to limit itself to any single issue, but the main focus of the Budget Session will

remain on discussing and passing the budget. In the all-party meeting, opposition parties also presented their demands and issues.

After the meeting, Dravida Munnetra Kazhagam (DMK) MP T.R. Baalu said, "We raised issues such as the problems of Tamil Nadu fishermen, the non-approval of the Hosur airport project, the demand for the return of Katchatheevu, US tariffs, and the Madurai and Coimbatore metro projects at the all-party meeting."

Nationwide Strike for Five-Day Banking Has Widespread Impact

Godda: The nationwide bank strike, called by the RRB Apex Union and the United Forum of Bank Unions (UFBU) in support of pending demands, including a five-day banking work system, had a widespread, organized, and effective impact in Godda district. The discipline, unity, and determination with which the bank employees, under the leadership of Nitesh Kumar Mishra, General Secretary of the Jharkhand State Rural Bank Employees Association, conducted the movement made this strike a powerful part of a nationwide mass movement, not just a local one. The striking employees started a massive rally from the regional office of Jharkhand Gramin Bank in Godda

with resounding slogans. The rally passed through the main streets of the city and reached near the Indian Bank, where strong slogans were raised against the policies of the central government and bank management. After this, the rally reached the State Bank of India, Bazaar branch, where the employees staged a sit-in protest and strongly presented their demands, including five-day banking. Finally, all the striking employees returned to the regional office of Jharkhand Gramin Bank, where the movement concluded with thunderous slogans. This system is already implemented in most of the country’s financial and government institutions.

Commissioner reviews revenue-related work of Banka district

In the meeting, the Additional Collector, Banka was directed to ensure that the monitoring of court cases related to government land is done through the District Revenue Branch. In case of losing a case related to government land,



instructions were given to appeal at a higher level. Instructions were given to maintain information about Forest Department land in every circle of Banka district. The Circle Officers of Banka

district were directed to prepare the Panchayat-wise/Halka-wise non-cultivable land register by February 15, 2026. Instructions were given to dispose of at least 90 percent of the total applications

received on Parimarjan Plus. The Additional Collector, Banka was directed to review the progress in PM Kisan Agristack at his level. The Additional Collector, Banka was directed to make every possible effort for the settlement of all government properties in the district and to ensure 100 percent recovery by the end of the financial year. He was also directed not to encourage departmental recovery. All Circle Officers of Banka district were directed to designate a seating place for each revenue employee so that the general public can easily meet them. The Deputy Collector, Land Reforms/all Circle Officers, Banka were directed to inspect their respective areas at their level. The Deputy Collector, Land

Reforms, Banka was directed to conduct regular court hearings and pass orders as per rules. All Circle Officers of Banka were directed to issue notices properly in mutation cases. Externed Criminal Arrested During Saraswati Puja Immersion

East Singhbhum: Police arrested Deepak Tiwari alias Kana, an externed criminal, on Monday night for attempting to disrupt peace during the Saraswati Puja immersion in the Bagbera police station area. The arrest was made at DB Road Chowk in Bagbera while the immersion procession was underway and a large crowd was present in the area. According to information, the police received a tip-off that Deepak Tiwari was trying to create trouble and instigate a dispute during the puja immersion. Upon receiving the information, a police team led by Bagbera police station in-charge Gopal Krishna Yadav reached the spot and promptly took the accused into custody. The arrested accused, Deepak Tiwari, is a resident of Ramnagar Branch Maidan area of Bagbera. According to police records, he was externed last month due to his criminal background and banned from entering the Bagbera police station area. Despite this, he was illegally residing in the area. Police say that Deepak Tiwari was hiding in Bagbera with the intention of committing a major crime. The police took his presence on the sensitive occasion of Saraswati Puja immersion seriously and averted a potential incident by taking timely action. The police are currently interrogating the accused.

Body of Young Man Found in Suspicious Circumstances

East Singhbhum: The body of a 33-year-old man, Akash, was found in suspicious circumstances in his room in Budhram Basti under the Sonari police station area on Tuesday, causing a sensation in the area. Upon receiving information about the incident, a crowd of local people gathered at the spot, after which the police were informed. Family members said that Akash had a love marriage about five years ago and had been living separately from his family with his wife since the marriage. For some time, there had been continuous disputes between the husband and wife. It is being said that his wife had left him two days ago, after which Akash was under mental stress and living alone. The deceased's mother, Poonam, and sister-in-law, Pinky, have leveled serious allegations against Akash's wife. They claim that Akash had fallen into deep depression due to his wife's behavior and her leaving him, which led him to take his own life. The family members have demanded action, alleging that this was a case of abetment to suicide. Upon receiving the information, the Sonari police arrived at the scene, took the body into custody, and sent it to MGM Medical College Hospital for post-mortem examination. Police officials stated that the initial investigation did not reveal any direct evidence of murder. Currently, the case has been registered as a death under suspicious circumstances.

As the state heads for the assembly poll, BJP has

India carries Asia's heaviest lung disease burden, Lancet study finds

NEW DELHI,Agency: India accounts for more than 43% of Asia's chronic respiratory disease-related disability, the highest share in the region, according to a new analysis published in The Lancet Respiratory Medicine on Wednesday. The study identifies air pollution as a major factor behind India's persistently high lung disease burden.

The study, based on estimates from the Global Burden of Disease 2023, found that Asia as a whole contributed nearly 67% of global disability-adjusted life years (DALYs) due to chronic respiratory diseases in 2023. India alone accounted for 43.3% of Asia's DALYs, while China contributed 27.8%, together making up over 70% of the regional burden, largely driven by population size and sustained exposure to risk factors.

In 2023, India's age-standardised DALY rate from chronic respiratory



diseases remained above 2,040 per 100,000 population, among the highest in Asia, reflecting a substantial burden of disability and premature mortality linked to respiratory conditions, despite a gradual decline since 1990.

Explaining what this translates to on the ground, Dr G.C. Khilnani, pulmonologist and Chairman, PSRI Institute of Pulmonary, Critical Care and Sleep Medicine, said respiratory illnesses such as pneumonia, asthma and

COPD are now among the most common conditions seen in clinical practice, with children and the elderly particularly vulnerable. He said delayed diagnosis worsens outcomes, while air pollution has emerged as a major driver-accounting for nearly half of COPD cases and a growing share of lung cancers, including among non-smokers.

South Asia, driven largely by India, recorded the highest age-standardised prevalence of chronic obstructive pulmonary disease (COPD) in Asia at 3,044 cases per 100,000 population. While prevalence across Asian regions was broadly similar, the analysis found that disability and deaths were significantly higher in lower-income regions, pointing to poorer outcomes rather than higher disease occurrence. Dr Ujjwal Parakh, Senior Consultant in Chest Medicine at Sir Ganga Ram Hospital, said chronic respiratory diseases-particularly COPD-are steadily increasing in India and are often diagnosed late due to low awareness and limited access to spirometry. With air pollution damaging lungs much like tobacco smoke, he said controlling pollution and improving early detection are critical.

The study identified ambient particulate matter pollution and household air pollution from solid fuels as major contributors to India's respiratory disease burden.

UGC anti-discrimination rules 2026: A bid for inclusion or risk of bias? Explained



New Delhi, Agency:When the University Grants Commission (UGC), the statutory body under the Union education ministry that regulates universities and colleges, notified its Promotion of Equity in Higher Education Institutions Regulations, 2026, it introduced a new set of rules that will apply across campuses nationwide.

The regulations govern how colleges and universities must prevent, identify, and respond to discrimination involving students, teachers, and staff.

On paper, the objective sounds straightforward. It seeks to ensure that no student, teacher, or staff member is denied dignity or opportunity in higher education because of identity.

In practice, however, the new regulations reach deep into the everyday functioning of campuses, shaping everything from admissions and hostels to classrooms, committees, and corridors.

The 2026 framework replaces the UGC's earlier equity rules and shifts the burden of compliance squarely onto institutions and their leadership.

Heads of universities and colleges are no longer just administrators; they are now the first line of accountability in preventing and responding to discrimination. New structures, new reporting mechanisms, and strict timelines are written into the rulebook, backed by the threat of serious penalties for non-compliance.

Yet, as has often been the case with regulations aimed at correcting long-standing social inequities, the real questions lie beneath the stated intent.

How wide is the definition of discrimination? How much discretion do institutional committees enjoy? What happens when complaints are contested, or when the process itself causes harm? And how prepared are campuses to balance speed, sensitivity, and fairness? And is it discriminatory against the non-reserved General Class students?

What the regulations aim to do

The objective clause sets the tone for the entire framework. It seeks to eradicate discrimination only on specified grounds like religion, race, caste, gender, place of birth, and disability.

The word "only" is significant, as it confines the scope of the regulations to discrimination based on specified identity grounds, excluding general grievances or academic disputes.

At the same time, the regulations explicitly prioritise certain groups, including:

- Scheduled Castes (SCs) and Scheduled Tribes (STs)
- Socially and Educationally Backward Classes (EBC)
- Economically Weaker Sections (EWS)
- Persons with disabilities

This prioritisation reflects a remedial approach, focusing on historically disadvantaged communities, while formally keeping the protection available to all stakeholders.

How the law frames discrimination and equityThe definitions section is one of the most consequential parts of the regulations.

"Discrimination" is defined broadly to include not only explicit acts but also implicit, indirect, or structural forms of

Is an archaeological marvel hiding near Chandigarh?

Chandigarh ,Agency: Walk down the narrow lanes of this small town - located about 45km southwest of Chandigarh - and you'd find it hard to believe that Chinese scholar Hiuen Tsang trod these very paths some 1,300 years ago. Or that north Indian ruler Prithviraj Chauhan had once passed this way at the head of his army.

It's as if history no longer felt welcome here and moved out, mournful and uncared for. But there was a time when history ebbed and flowed through its narrow lanes. Sirhind - or Sar-iHind, the crown of India - was, after all, the last major outpost before invaders reached the Yamuna. Temples of the Hindu Shahis - who made Sirhind their capital, with its grandeur said to be second only to Lahore's - still stand south of Islamabad, the oldest surviving temples in Pakistan.

But monuments and structures that are often eloquent narrators of past glories stand in Sirhind as mute spectators, listlessly dotting farmlands and alleyways. In many cases,



they exist - plastered, painted over, forgotten - as bricks that were repurposed as construction material to build nameless walls of homes that have sprung up in recent decades.

The town, which forms a twin city with the adjacent Fatehgarh Sahib, has not only shrunk in size and significance, it has also gone missing from Punjab's mindscape and its cultural discourse. It is where Humayun defeated the Suris to re-establish Mughal rule and where Guru Gobind Singh's sons were so cruelly bricked up alive. Sirhind is said by some to go back to the time of the Mahabharata, a melting pot of lore and legend. But, then, how did history itself become a

victim in historic Sirhind?

Dr Daljit Singh, professor of history at Punjabi University, Patiala, told media that Sirhind is a treasure trove for archaeologists, but it hasn't got its due. Encroachments are gobbling up what should be protected spaces. The sense one gets on talking to locals is that every brick and old structure here can tell its own history. The only tough part is to actually find and identify them for what they really are.

There is little evidence of any sustained effort by Archaeological Survey of India (ASI) to explore the historical importance of the area. Despite its rich past as a major provincial centre, there has not been a survey in years to identify historical remains that may lie buried beneath the ground.

Some sites, like Gurudwara Shri Fatehgarh Sahib, Rauza Sharif Shrine and a Jain Mandir, are well maintained. But many historical places like Jahazi Haveli of Diwan Todar Mal - not to be confused with Raja Todar Mal of Akbar's Navratna fame - Aam Khas Bagh and Sadna Kasai Masjid have remained neglected for long.

In Republic Day messages, Trump hails historic bond, Xi talks of dragon-elephant tango

NEW DELHI,Agency: US President Donald Trump and his Chinese counterpart Xi Jinping were among the global leaders who extended greetings to the Indian govt and people on Republic Day. While Trump underlined the significance of ties between the world's oldest and largest democracies, Xi said in a message to President Droupadi Murmu that India and China were "good neighbours, friends and partners" and a dragon-elephant dance was the right choice for both countries.

"On behalf of the people of



the United States, I extend my heartfelt congratulations to the govt and people of India as you celebrate your 77th Republic Day. The United States and India share a historic bond as the world's oldest and largest democracies,"

said Trump, according to a post on X by the US embassy.

Secretary of State Marco Rubio, too, put out a congratulatory message, saying the two countries shared a historic bond. "From our close cooperation on defence, ener-

gy, critical minerals, and emerging technologies to our multi-layered engagement through the Quad, the US-India relationship delivers real results for our two countries and for the Indo-Pacific region," he said.

Thrilled to see US-made aircraft in Indian skies, symbolises strength of our ties: Gor US Secretary of State Marco Rubio said he was looking forward to working with India to "advance our shared objectives in the year ahead". US ambassador Sergio Gor said he was thrilled to see US-made air-

craft soaring in the Indian sky and called it a powerful symbol of the strength of the US-India strategic partnership.

In his message, Xi said that India-China relations have continued to improve and develop, aligning with the fundamental interests of both the countries and their people, and are of great significance for maintaining and promoting world peace and prosperity.

Xi stressed that China has always believed that being good neighbours, friends and partners who help each other succeed, and achieving

the "dragon and the elephant dancing together", is the right choice for both China and India, state-run Xinhua news agency reported. The Chinese president expressed hope that both sides will adhere to the important consensus that China and India are "partners for cooperation and opportunities for development", strengthen strategic communication, expand exchanges and cooperation, address each other's concerns, and promote the healthy and stable development of China-India relations.

Trump’s Gaza ‘Board of Peace’ undermines the UN

United States President Donald Trump is bent upon resetting the world order to establish America’s hegemony and replacing multilateralism with transactional deal-making. Bullying, weaponising tariff systems, and coercive diplomacy are the strategic tools he uses to achieve his stated goals. His impulsive ways have pretty much become the new normal in international diplomacy. The latest in a series of shenanigans that have come to define Trump’s persona is the idea of the Gaza ‘Board of Peace’. The proposal is a mockery of the United Nations and the time-tested instruments of multilateralism. The maverick move is in sync with Trump’s propensity for deal-making outside traditional multilateral frameworks. Projected as a pragmatic, business-like mechanism to stabilise Gaza, the concept implicitly challenges the relevance of international institutions in managing one of the world’s most intractable conflicts. At its core, the proposal demonstrates Trump’s scepticism about the UN, which he has repeatedly criticised as inefficient, biased, and overly bureaucratic. The ‘Board of Peace’, especially if it is dominated by select regional powers or US-aligned actors, would signal a shift from universal multilateralism to ad hoc governance. A swift pushback to this preposterous idea is a welcome development. Two permanent members of the United Nations Security Council (UNSC) — China and France — have rejected Trump’s invitation to be on the Board of Peace. They have rightly pledged their continued allegiance to the spirit of multilateralism and the principles of the UN Charter. India too had received an invitation from Trump but is yet to respond.

India should outright reject the idea instead of taking cover under diplomatic niceties. On the other hand, Pakistan, which loses no opportunity to display its obsequiousness to please the Trump administration, has accepted the invitation to join the board. Any credible peace effort in the war-ravaged Gaza must grapple with realities Trump often sidesteps: international law, civilian protection, and the need for inclusive governance. If the Gaza initiative prioritises optics over substance, it risks becoming another plan that collapses under the weight of ground reality. Peace imposed without legitimacy, consent, and accountability rarely survives. Traditionally, New Delhi has supported a two-state solution while balancing strong ties with Israel and the Arab world. A weakened UN system complicates India’s diplomatic calculus, as New Delhi often relies on multilateral forums to promote stability without direct intervention. Trump’s latest brainwave on Gaza looks less like a diplomatic initiative and more like a real estate advertisement for a distressed asset. Fresh from a brazen operation to extract Nicolás Maduro from Venezuela to “secure the oil,” and amid the renewed attempt to capture Greenland, Trump has now turned his gaze to the rubble of the war in West Asia. His ‘Board of Peace’ is designed to manage the reconstruction not through aid grants, but through investment tranches.

World reorders through issue-based power and partnerships

What appears today as global uncertainty is, in reality, the loud and often confused reaction to a structural transformation that has been underway for decades. The current noise, amplified by sharp political rhetoric, executive orders, and dramatic leadership statements, particularly from the United States, does not signal chaos. Instead, it reveals what was long concealed beneath layers of managed narratives: the gradual collapse of the single-superpower world order and the exposure of false dependencies built around it.

The idea of a stable, US-led global order rested heavily on assumptions rather than sustainable realities. Transatlantic unity, for instance, was often presented as a natural alliance of shared values. In truth, it was sustained by Europe’s over-reliance on American strategic protection and decision-making, even in areas where Europe should have exercised independent judgment.

The recent acknowledgments by European and Canadian leadership of ruptured transatlantic relations did not create the rupture; they merely admitted its existence. The illusion of unconditional US support had already begun to fray.

Similarly, what was once promoted as “multilateralism” often functioned as a carefully managed grouping of middle powers operating within frameworks designed or approved by the dominant superpower and its economic institutions. This model is now breaking down.

As economic capacities,



technological strengths, and supply-chain dominance are distributed across regions and countries, no single power can dictate outcomes across all domains. The fragmentation of economic influence has made centralized control not only ineffective but counterproductive.

A critical turning point in this process was the failure of global leadership, particularly American leadership, to confront China’s monopolistic trade practices and its growing control over global supply chains. Ironically, this dominance was enabled by the very philosophy that encouraged outsourcing manufacturing to China in pursuit of short-term profits. Once that compromise was made, reversing it became

nearly impossible. No middle power can now expect another dominant actor to restrain China on its behalf. Each must find its own balance.

This reality marks the end of classical multilateralism and the rise of a more pragmatic, issue-based bilateralism. Countries are increasingly aligning not through permanent blocs, but through flexible partnerships based on specific interests—security, technology, energy, or trade. This is not a retreat from cooperation, but a redefinition of it. The expectation that security, economic stability, or diplomatic leverage can be outsourced indefinitely to a single umbrella power has proven unsustainable.

Europe’s current strategic

recalibration illustrates this shift. Having ceded much of its strategic autonomy to the United States while becoming economically intertwined with China, Europe now faces the task of rebuilding balance. Developments—from debates over Greenland to internal EU security initiatives—have served as wake-up calls. While corrective announcements have been made, much of the damage to trust and structure has already occurred. The European Union’s collective effort to find an independent equilibrium reflects a broader global trend.

In this changing landscape, India stands out as a country increasingly appreciated for its strategic consistency. India’s experience demonstrates that resilience comes from

maintaining autonomy, resisting external pressure, and anchoring policy in domestic strengths—particularly a large, consumption-driven economy. Export-dependent economies remain more vulnerable to external shocks and coercion, whereas economies with strong internal demand possess greater strategic flexibility.

The emerging global order will likely be characterized by smaller, resilient supply chains aligned with regional security and trust networks. This necessitates renewed emphasis on good-neighboring relations and regional cooperation. Economic survival and employment stability will depend less on distant guarantees and more on local and regional equilibrium.

At a societal level, this transition also exposes the costs of excessive materialism and over-dependence—whether on global systems or technology. Even artificial intelligence, while transformative, may reveal social and economic fractures rather than mask them. Technology should enhance the quality of life, not replace human agency or values. A return to value-based living, balanced with innovation, may be one of the quieter but deeper consequences of this global shift.

Finally, the fear of large-scale global war is often overstated. Prolonged conflicts have proven economically and politically unsustainable, even for the strongest powers, as seen in Vietnam, Afghanistan, and Iraq. The coming years may witness localised conflicts and strategic tensions, but major global wars or territorial takeovers are increasingly unaffordable.

London: Protest demanding justice for Bangladeshi Hindus sees overwhelming turnout



Amid the cold weather conditions, a large crowd gathered at the Parliament Square in London on Wednesday in a demonstration calling for international attention against the continued torture, persecution and killing of minorities in Bangladesh, a statement by the Bangladesh Hindu Association and Bengali Hindu Adarsh Sangha said. Organised by the Bangladesh Hindu Association (BHA) and supported by INSIGHT UK and the Bengali Hindu Adarsh Sangha (BHAS), this British Hindu diaspora event drew an audience of over 500 participants representing students, professionals, parents with children, elderly activists and interfaith leaders. Attendees included Baroness Sandeep Verma, Lord Dolar Popat, former MP Virendra Sharma, MP Navendu Mishra, MP Luke Murphy, MP Jim Dickson, Birmingham Cllr Andrew Hardie, and MP Andrew Mitchell. All dignitaries accepted the fact that this is no less

than an ethnic cleansing happening in Bangladesh and assured their full support to the diaspora in bringing the matter to the UK government. As per the statement, a spokesperson of the event highlighted quite a few issues that the minority communities of Bangladesh are suffering. These include long-standing patterns of discrimination, targeted violence, killings and demographic decline suffered by the minority communities in Bangladesh and first-hand testimonies from families of victims,

underscoring the human cost. Grave concerns over the arrest of interfaith religious voice Chinmaya Prabhu and the public lynching of Dipu Das, followed by 15 Hindus killed in a planned genocide. Social media platforms buzzed with photos and livestreams from the demonstration, amplifying reach beyond London and garnering support from global audiences, the statement said. It further noted that the organisers had the following 4-point demands, and regarding this, a memorandum was also submitted to PM Keir Starmer. These included immediate suspension of UK aid and trade with Bangladesh till it takes necessary action against the perpetrators; formal Parliamentary Action by issuing an urgent Ministerial Statement and enabling full parliamentary debate and scrutiny; targeted international accountability by pursuing international scrutiny and applying targeted sanctions against perpetrators.

Study finds a unique sound which alleviates motion sickness

A research group has discovered that using a device that stimulates the inner ear with a specific wavelength of sound reduces motion sickness. Even a single minute of stimulation with a unique sound, called ‘sound spice,’ reduced the staggering and discomfort felt by people that were asked to read a document in a moving vehicle. Their findings suggest a simple and effective way to alleviate this common disorder. A research group led by Takumi Kagawa and Masashi Kato at Nagoya University Graduate School of Medicine.

"Our study demonstrated that short-term stimulation using a unique sound called 'sound spice' alleviates symptoms of motion sickness, such as nausea and dizziness," Kagawa said. "The effective sound level falls within the range of everyday environmental noise exposure, suggesting that the sound technology is both effective and safe," added Kagawa. This discovery is an important expansion of recent findings about sound and its effect on the inner ear.

Increasing evidence has suggested that stimulating the part of the inner ear associated



with balance using a unique sound can

potentially improve balance. Using a mouse

model and humans, the researchers identified a

unique sound at 100 Hz as being the optimal frequency.

"Vibrations at the unique sound stimulate the otolithic organs in the inner ear, which detect linear acceleration and gravity," Kato explained. "This suggests that a unique sound stimulation can broadly activate the vestibular system, which is responsible for maintaining balance and spatial orientation" added Kato. To test the effectiveness of the devices, they recruited voluntary participants who were exposed to the unique sound. Following the stimulation, motion sickness was induced by

a swing, a driving simulator, or riding in a car.

The researchers used postural control, ECG readings, and Motion Sickness Assessment Questionnaire results to assess the stimulation's effectiveness.

The researchers found symptoms such as "lightheadedness" and "nausea," which are often seen with motion sickness, were alleviated. "These results suggest that activation of sympathetic nerves, which are often dysregulated in motion sickness, was objectively improved by the unique sound

exposure," Kato said. "The health risk of short-term exposure to our unique sound is minimal," Kagawa said. "Given that the stimulus level is well below workplace noise safety standards, this stimulation is expected to be safe when used properly." Their results suggest a safe and effective way to improve motion sickness, potentially offering help to millions of sufferers. The researchers plan to further develop the technology with the aim of practical application for a variety of travel situations including air and sea travel.

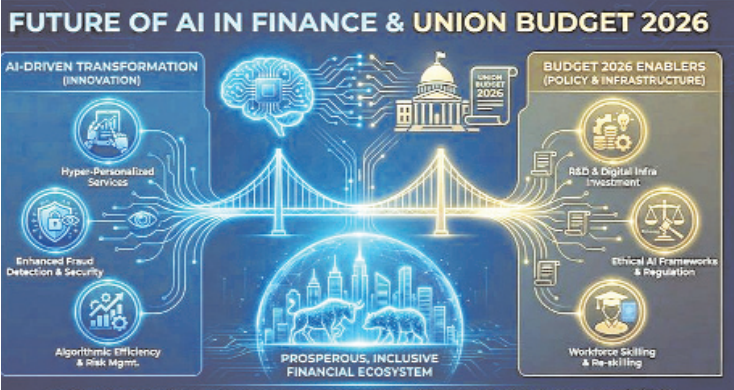

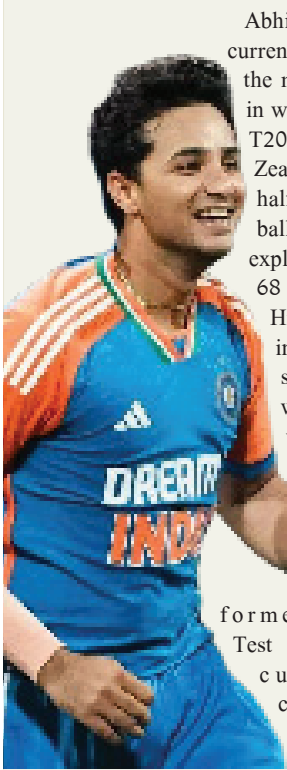

He said that the 'Universe Boss' Chris Gayle has done this for a very long time, perhaps for more than a decade. According to Aakash, Abhishek Sharma might surpass Chris Gayle in the future, but in the current comparison, Gayle's impact and the fear he instilled were far greater. Chris Gayle may no longer be active in international or professional cricket, but there was a time when he single-handedly changed the course of a match. Bowlers looked helpless against his batting, and the pressure on the opposing team was clearly visible. There was probably no more dangerous batsman than him in T20 cricket at that time. As for Abhishek Sharma, he was dismissed on the very first ball in the previous match while attempting to hit a six, but this didn't deter him from maintaining his aggressive approach.

Indian team aims to maintain winning momentum in the fourth T20

In the last match, Kuldeep bowled three expensive overs, giving away 32 runs, but the good performance of other bowlers Jasprit Bumrah and Hardik Pandya helped the Indian team dismantle the opposition's batting lineup and secure the win. Kuldeep had also failed to impress in the ODI series earlier, where he took three wickets in three matches. Varun was rested in the last match, but his bowling was ineffective in the first two matches as well. Therefore, it is possible that

Ravi Bishnoi might play in this match. Bishnoi took two wickets for 18 runs in the last match. If all-rounder Axar Patel, who is returning to the team, plays in this match, his fitness will also be under scrutiny. He was out of the last two matches due to a finger injury. The Indian team will want its spinners to also find their rhythm in this match, while the batting department remains strong. India's batting has been aggressive in both the previous matches. They scored runs at a rapid pace and secured victories in the second and third T20 Internationals. The same story is likely to unfold in this match as well. In this series, only Samson has failed to perform. He has scored only 16 runs in three matches at an average of 5.33, raising questions about his place in the team. However, with Tilak Varma being unavailable, he is expected to retain his place in this match. On the other hand, the New Zealand team has not been able to compete with the Indian team in this series so far.

Sri Lanka Women's Cricket Team to Tour West Indies for Six-Match White-Ball Series

The Sri Lanka women's cricket team will tour the West Indies from the end of February to the beginning of March, where the two teams will play a six-match white-ball series. (SLC) said in its official statement, "The Sri Lanka national women's team will tour the West Indies during February-March 2026, where they will play a three-match ODI series and a three-match T20 International series. The tour will begin with the ODI series, followed by the T20 matches, all to be held in Grenada." The Sri Lankan team will be looking to end their winless streak in T20 Internationals since the 2024 Asia Cup. The host West Indies, on the other hand, are confident after their recent home performances, having won T20 series against Bangladesh and South Africa in their previous tours. The two teams last met in the Caribbean in 2024, where Sri Lanka swept the ODI series 3-0, while West Indies won the T20 series 2-1.

T20 matches should be played during the day: Ashwin

Former Indian spinner R Ashwin has said that T20 cricket matches should be played during the day. Currently, these matches are played at night. Ashwin said that holding matches during the day in the future will also help bowlers, maintaining a balance between bat and ball. Ashwin said that currently, with matches being played at night, batsmen dominate and even chase down big targets. He said that in the second T20 against New Zealand, the Indian team chased down a target of over 200 runs with five overs to spare. This shows how difficult it is to bowl during dew. In such a situation, there is nothing left for the bowlers



in the match. Ashwin said that due to the dew, it becomes almost impossible for bowlers to make an impact. Ashwin said, "The New Zealand bowlers looked frustrated during India's batting. It is not right to send teams to play in such dew conditions. In such situations, cricket skills are not even needed." He added, "If matches were played on these same pitches in the afternoon, even 150 to 170 runs would be difficult to score." According to Ashwin, due to the dew, runs are scored even on good balls. Therefore, it is necessary to remove this kind of imbalance. There is a huge difference in the wicket between day and night.

Jos Buttler becomes the second English player to play 400 international matches

England's experienced wicketkeeper-batsman Jos Buttler has achieved a major milestone. He has become only the second English player to play 400 matches in international cricket. The right-handed batsman achieved this feat during the third ODI against Sri Lanka at the R. Premadasa Stadium in Colombo on Tuesday. The 35-year-old Buttler is now only behind legendary fast bowler James Anderson in this regard. Anderson has played a total of 401 international matches for England across all three formats and is the country's most capped player. Anderson, considered one of the greatest seamers in world cricket, has taken a total of 991 wickets in his career. Talking about Jos Buttler's international career, he has scored 12,291 runs so far, including 14 centuries. In Test cricket, Buttler has scored 2,907 runs in 100 innings of 57 matches. His average in this format is 31.94, including two centuries and 18 half-centuries. In ODI cricket, Buttler has scored 5,515 runs in 171 innings of 198 matches. During this



time, his average has been 39.11, and he has hit 11 centuries and 29 half-centuries. In T20 International cricket, Buttler has scored 3,869 runs in 132 innings of 144 matches. His average in this format is 35.49, including one century and 28 half-centuries. Jos Buttler, a two-time ICC white-ball title winner, is also part of the upcoming ICC Men's T20 World Cup 2026, which will begin on February 7 in India and Sri Lanka. England has announced its squad for this tournament, with star batsman Harry Brook named as captain.

Fast bowler Kane Richardson retires from professional cricket

Australian veteran fast bowler and Big Bash League (BBL) legend Kane Richardson has announced his retirement from professional cricket. Richardson bid farewell to cricket after a glorious 17-year career. He made the announcement on Monday via his Instagram account. Kane Richardson has been one of the most successful bowlers in the history of the Big Bash League. He ends his career as the fifth-highest wicket-taker among male bowlers in the BBL, with 142 wickets in 15 seasons. He achieved this feat while playing for the Adelaide Strikers, Melbourne Renegades, and Sydney Sixers. Internationally, Richardson played 25 ODIs and 36 T20 Internationals for Australia. It is noteworthy that the 2030 FIFA World Cup will be special, as it will also celebrate the 100th anniversary of the tournament. On this occasion, the Latin American countries of Uruguay, Argentina, and Paraguay will also host one match each.
